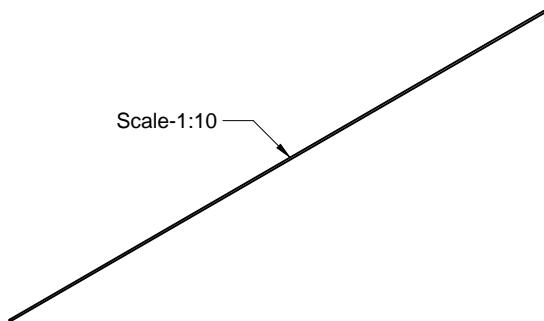
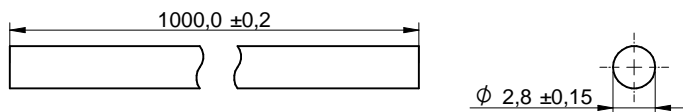

#### Product specific:

#### Cleaning and Washing:

- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components




#### Packaging:


