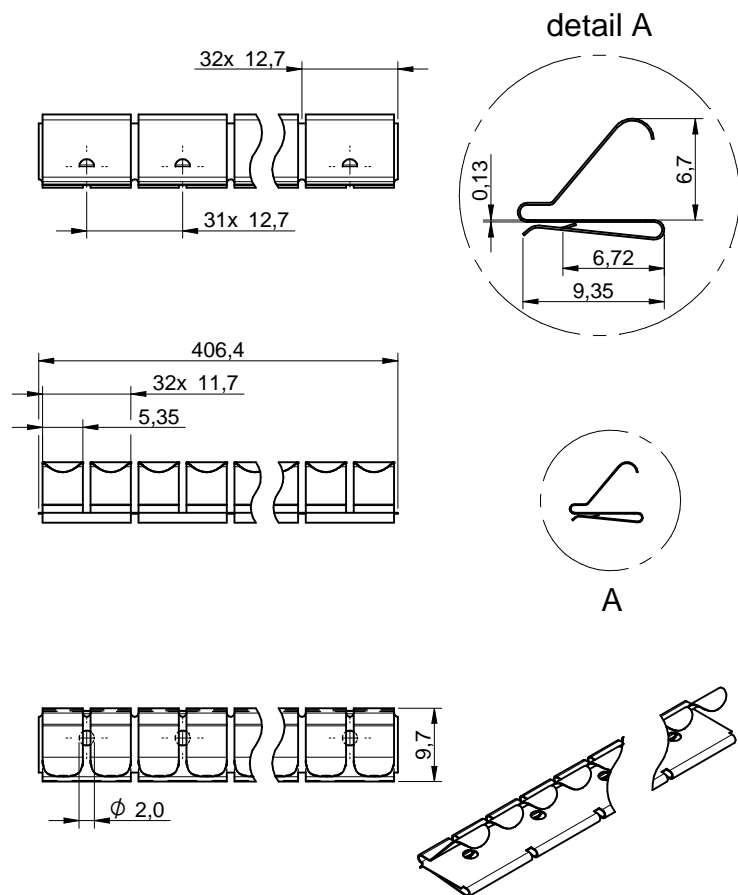



#### Storage Conditions:


