#### Product Specific:

#### Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the component, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product.

#### Potting:

- If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. - Stacking height of more than seven layers is not recommended.




#### Packaging:

- Recommended use is between 10% and 30% material compression. Use of material beyond recommended compression rate may result in excessive silicone oil exudation.
- It is recommended to compress the material with equal pressure on the whole surface. Partial excessive stress may also result in excessive oil exudation.
- The temperature rise of the component must be taken into consideration. The operating temperature is comprised of ambient temperature and temperature rise of the component. The operating temperature of the component shall not exceed the maximum temperature specified.


