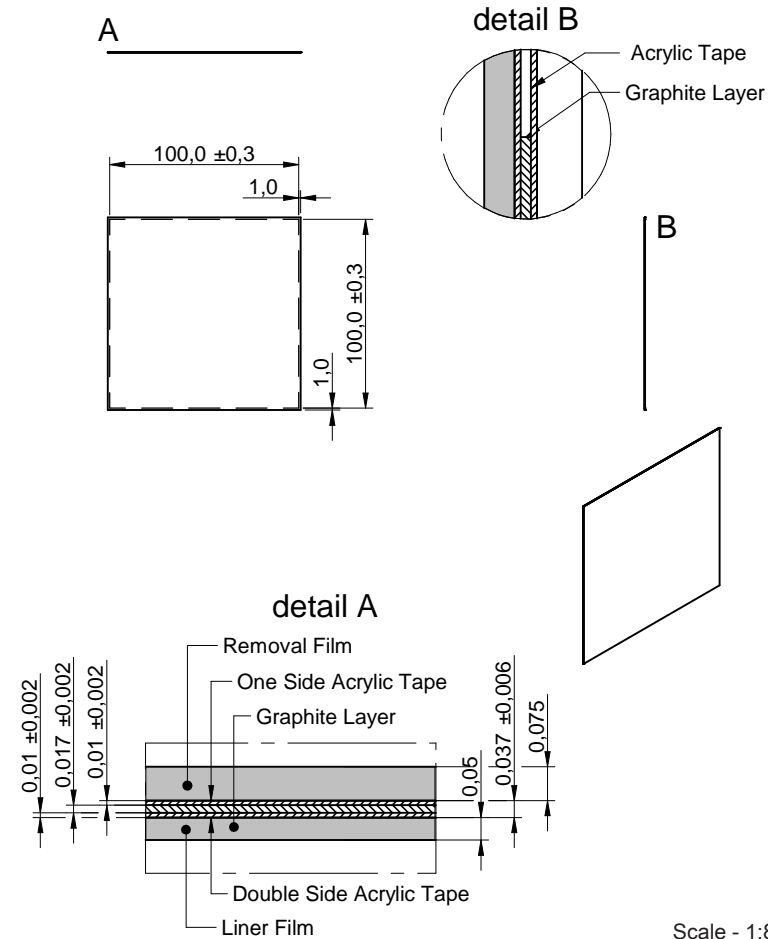



Packaging:


