- Design the right angle part with consideration of the wave soldering process so that the parts will not touch the soldering wave during the soldering process or protect the switch part with cover fixture. Melting of the switch may cause malfunction.

Cleaning and Washing:

If a series is washable, the general information section in the datasheet will contain the washability guidelines. Should there be no
information regarding washability, the product has not been constructed to withstand a washing process. Washing agents used during





- 2. Fix one side of the tweezers to hold the one side of switch cover and the other side of tweezer to hold the moveable actuator in vertical direction.
- 3. Using slide force to change the setting from ON to OFF or OFF to ON.


