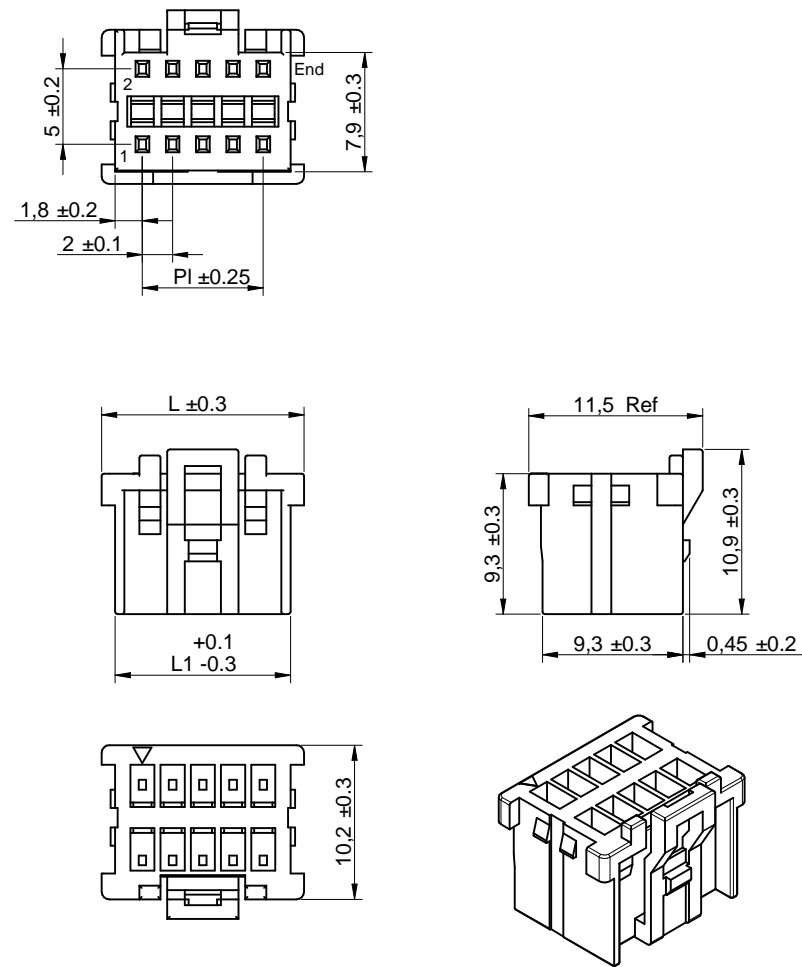





#### Storage Conditions:


