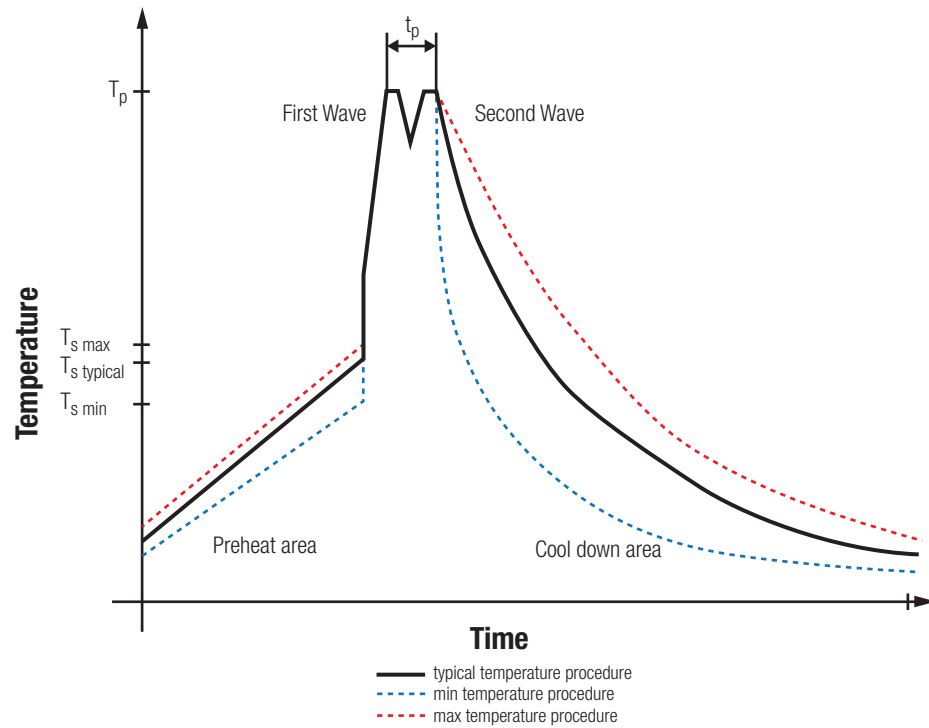



Packaging:


