



Soldering:

- Do not expose the components to direct sunlight.
- The storage conditions in the original packaging are defined according to DIN EN 61760-2.
- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.

Handling:

- Do not repeatedly operate the component with excessive force. It may damage or deform the component resulting in malfunction.
- In the case a product requires particular handling precautions, in addition to the general recommendations mentioned here before, these
