








Recommended Hole Pattern: [mm]





Product Specific:

Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the
 components. Washing agents may have a negative effect on the long-term functionality of the product.
- Using a brush during the cleaning process may damage the component. Therefore, we do not recommend using a brush during the PCB cleaning process.

Potting and Coating:

If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinking

Storage Conditions:


Packaging:


