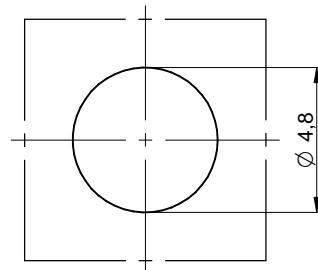


sectional drawing A-A

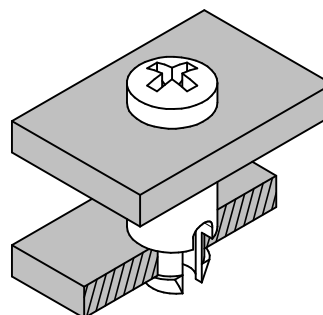

#### Product Specific:

#### Cleaning and Washing:



#### Packaging:


