Typical Impedance vs. Frequency Characteristics

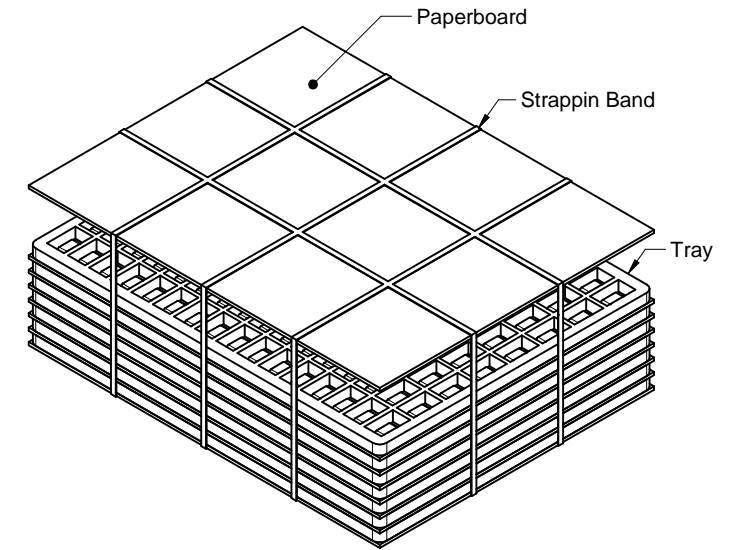

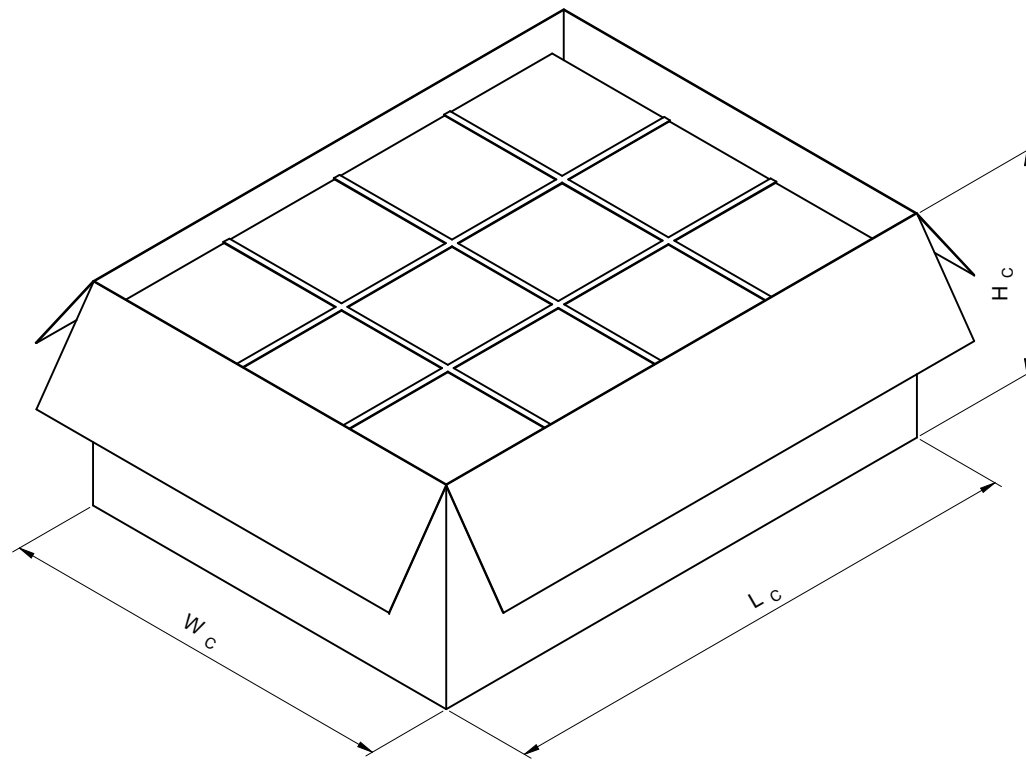



Cleaning and Washing:



Packaging:


