Common Mode

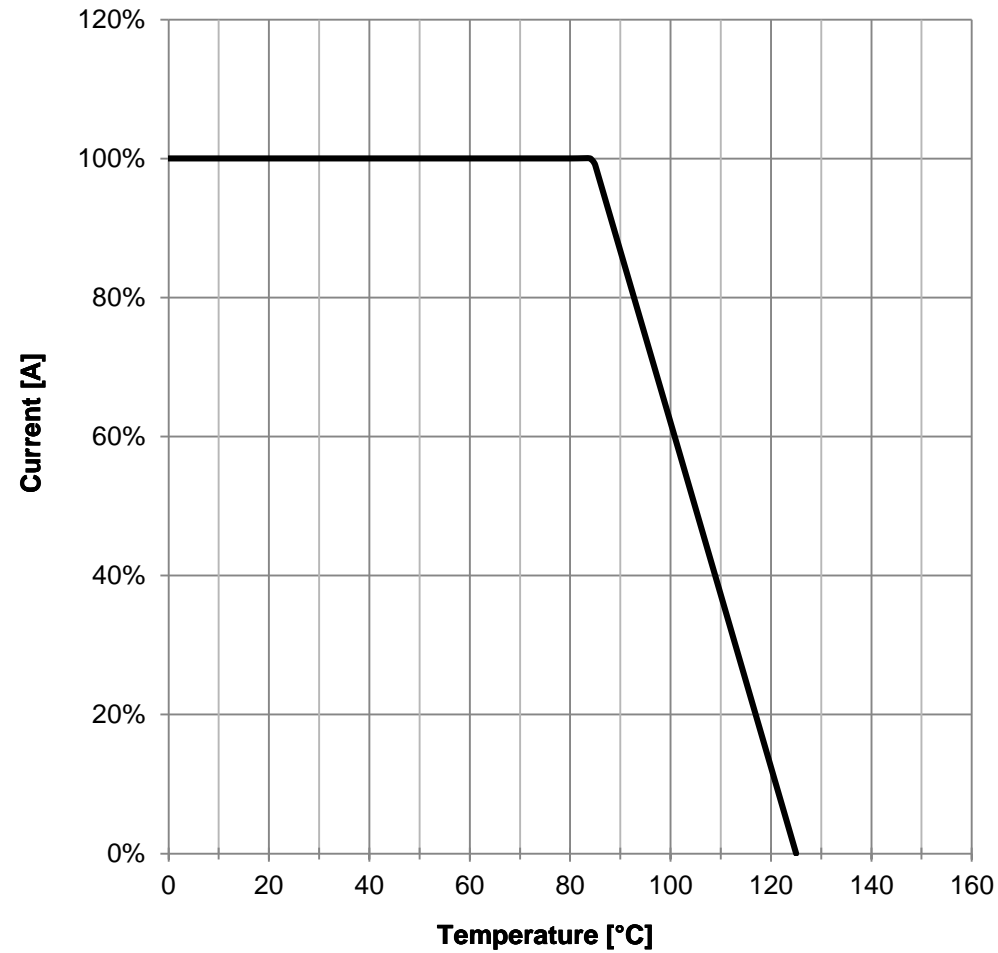



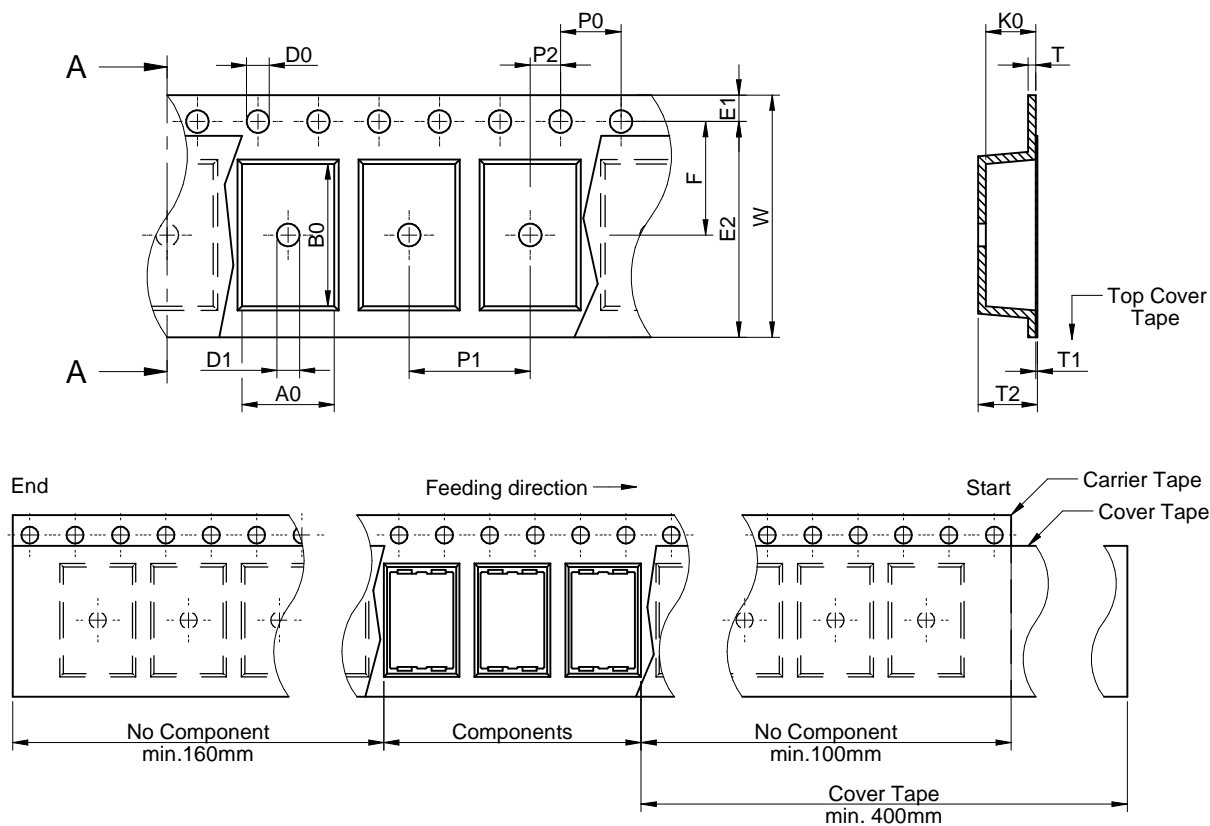
Derating Curve:
