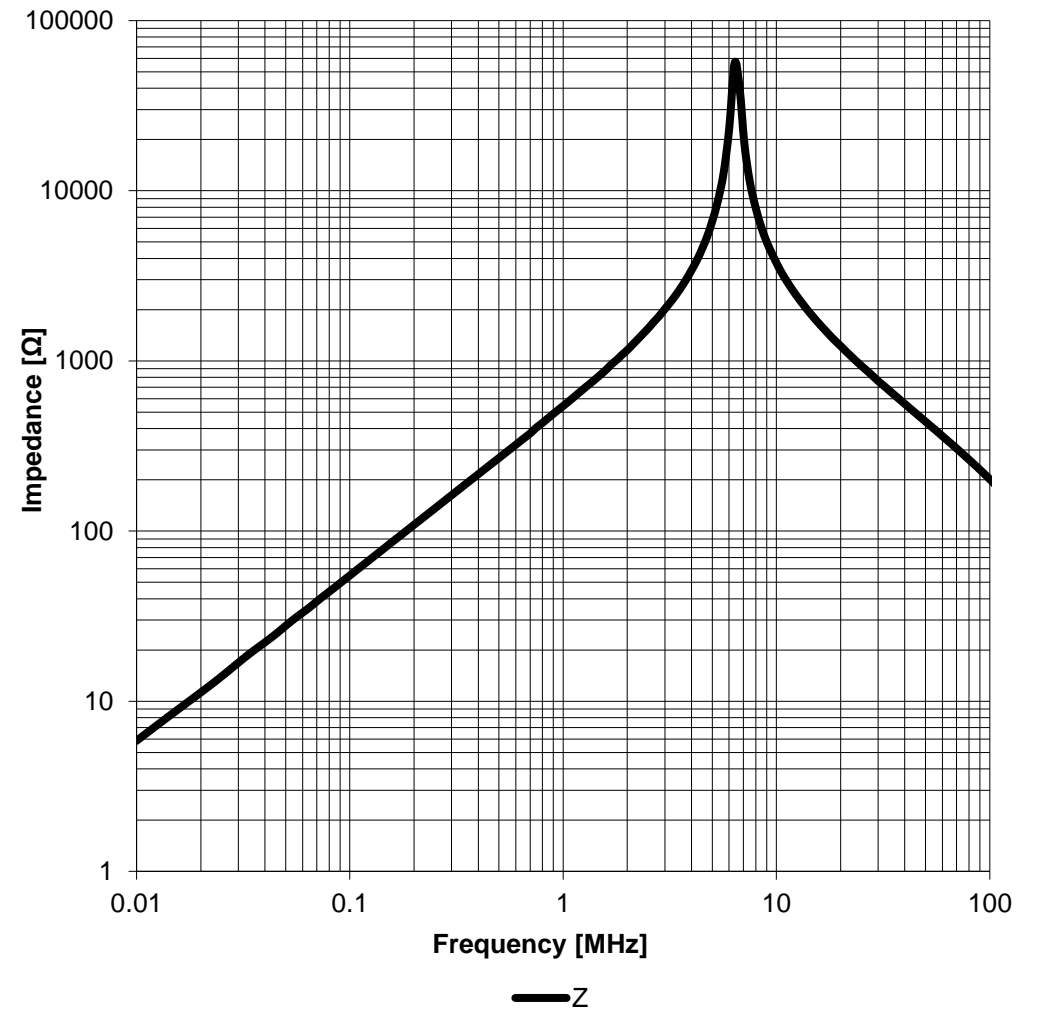

### Typical Impedance Characteristics:



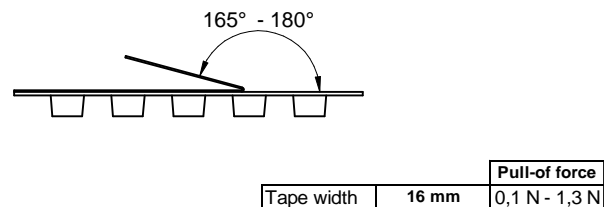

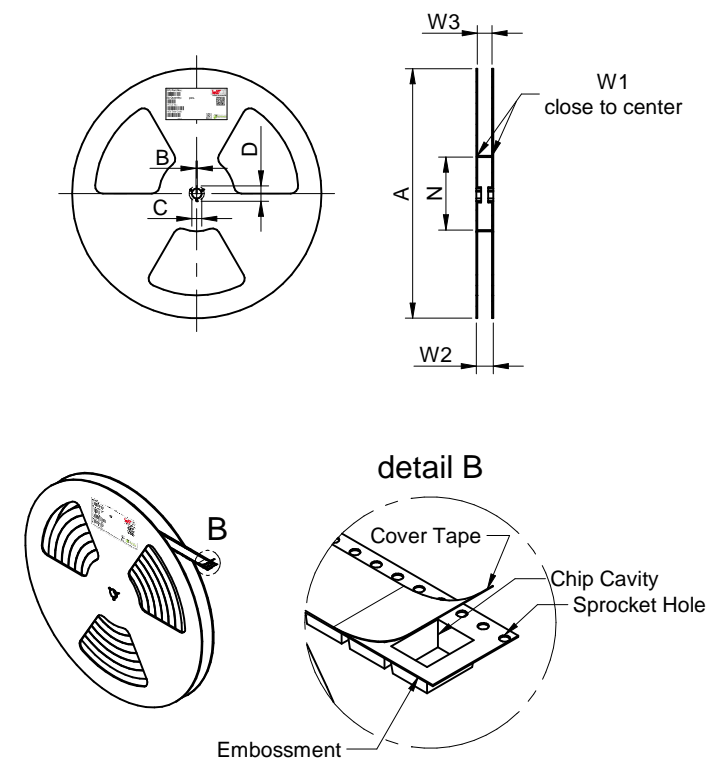

#### Soldering:




