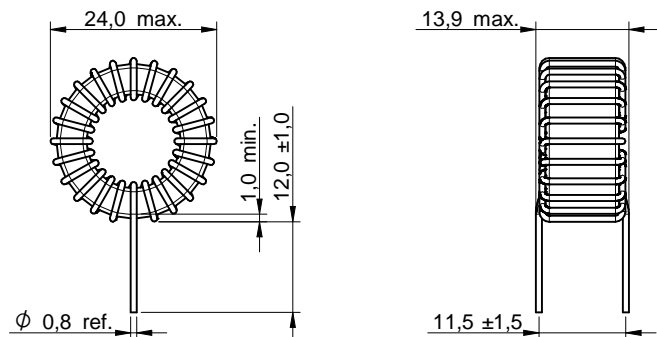
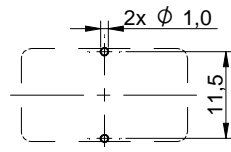


**Recommended Hole Pattern: [mm]**

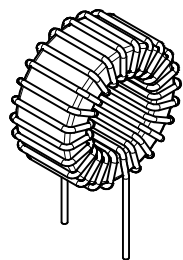

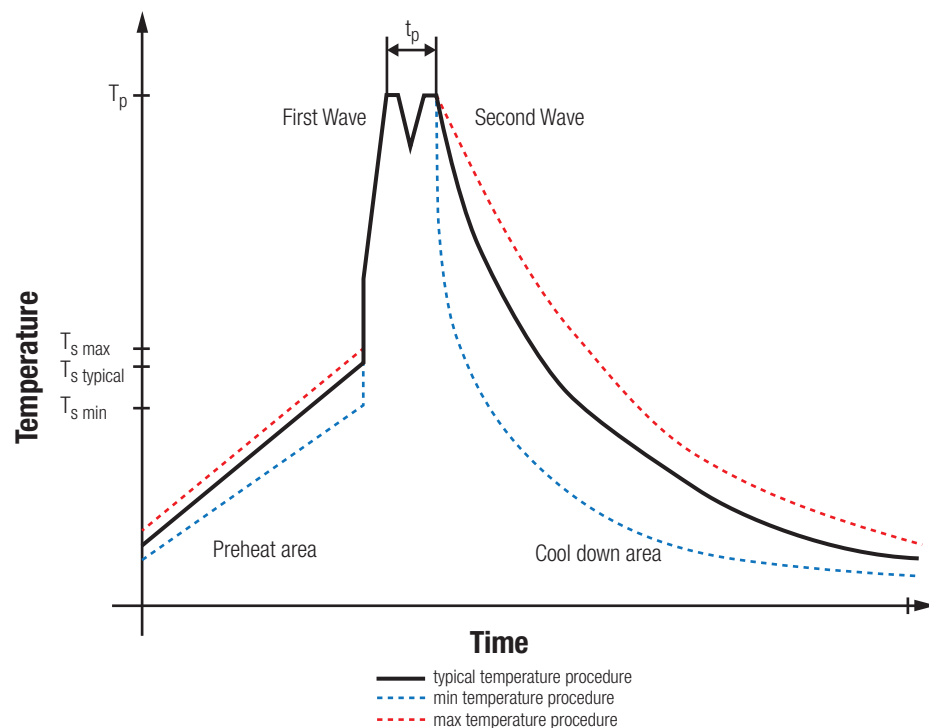
### Typical Inductance vs. Current Characteristics:

#### Soldering:



## Storage Conditions:


