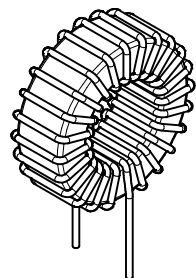
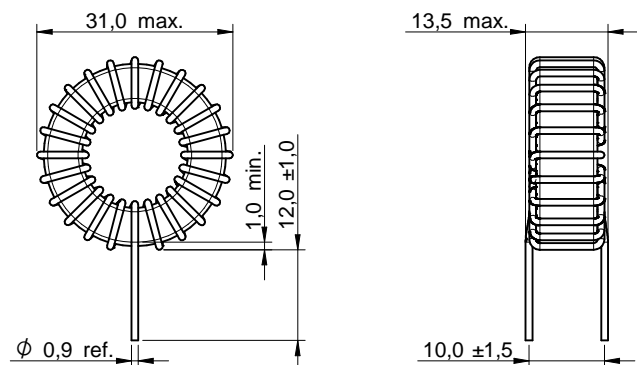
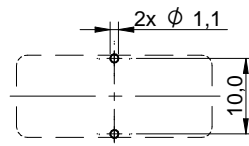


**Recommended Hole Pattern: [mm]**

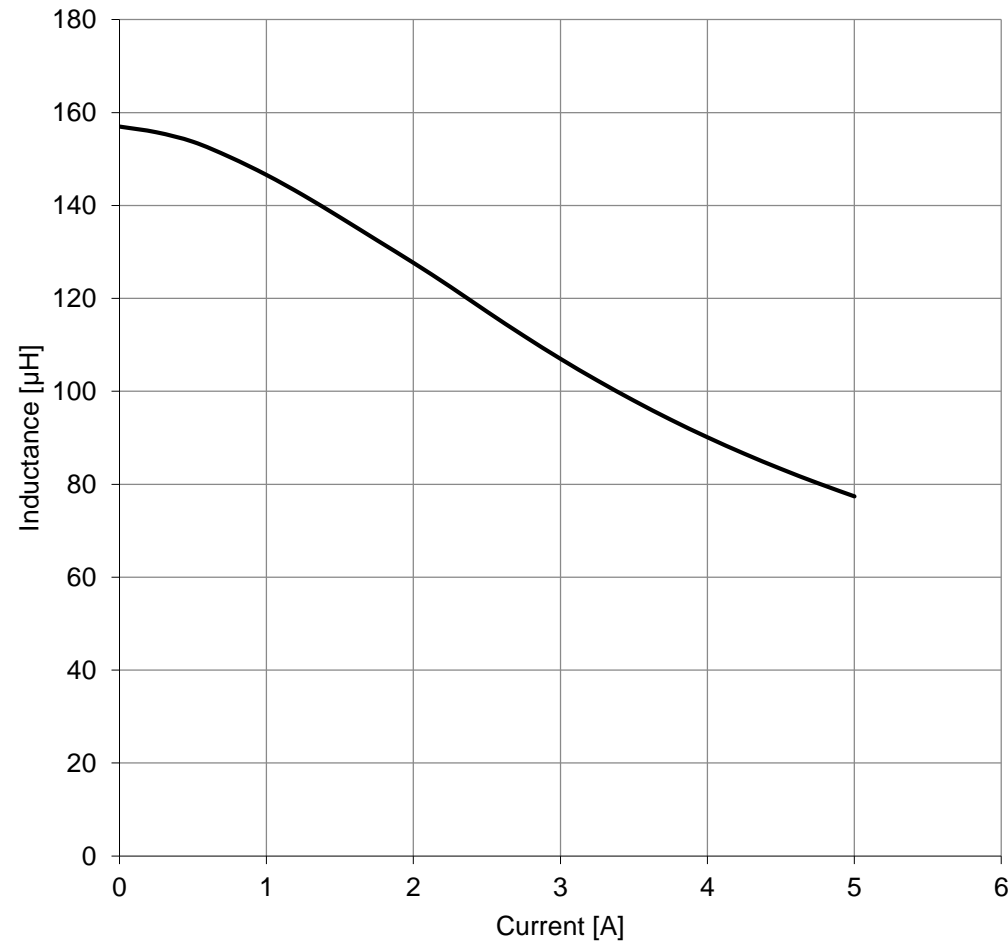



## Storage Conditions:


