### Typical Common Mode Insertion Loss Characteristics:

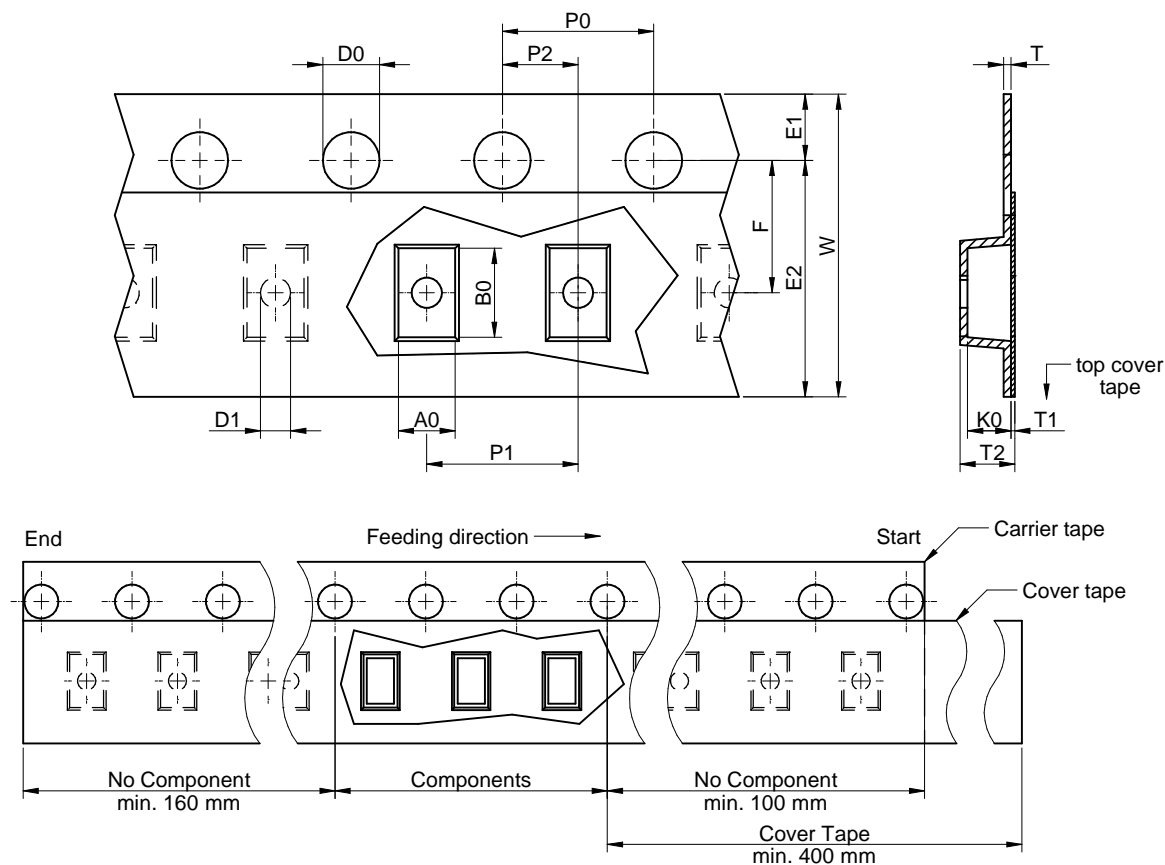
