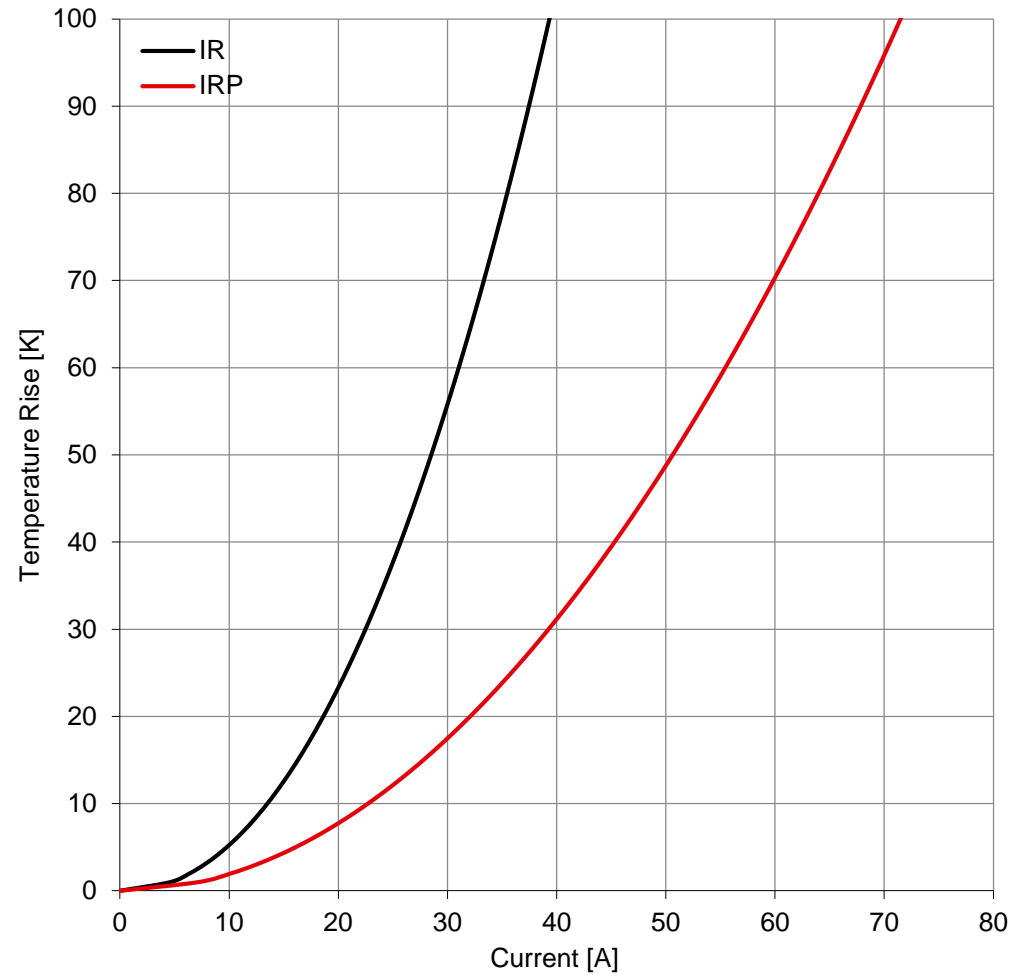
**Typical Inductance vs. Current Characteristics:**







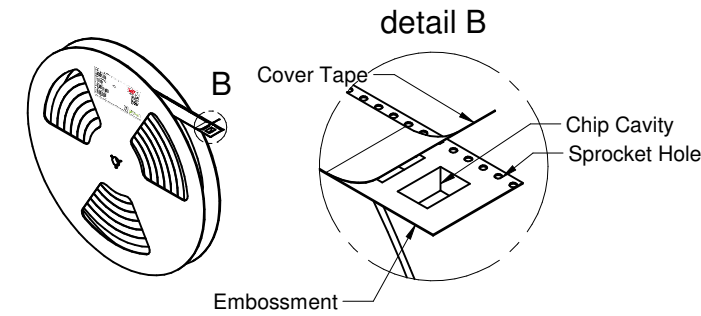
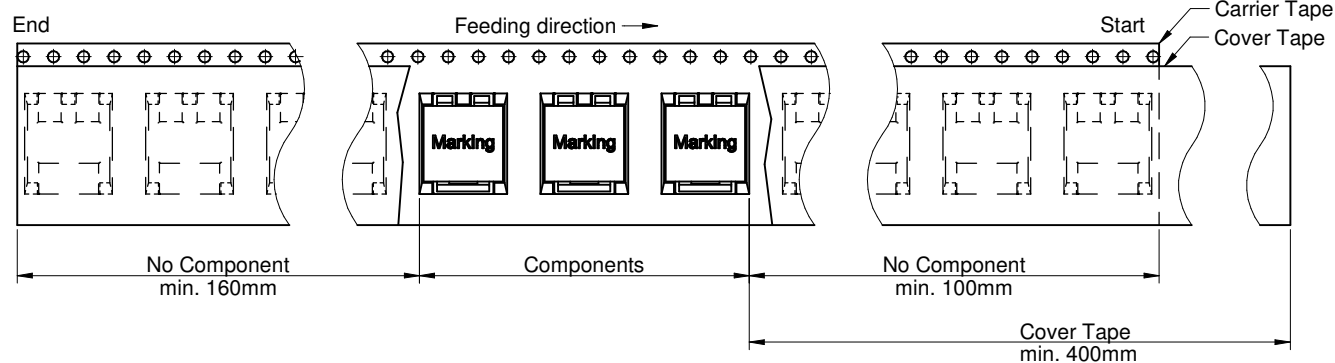
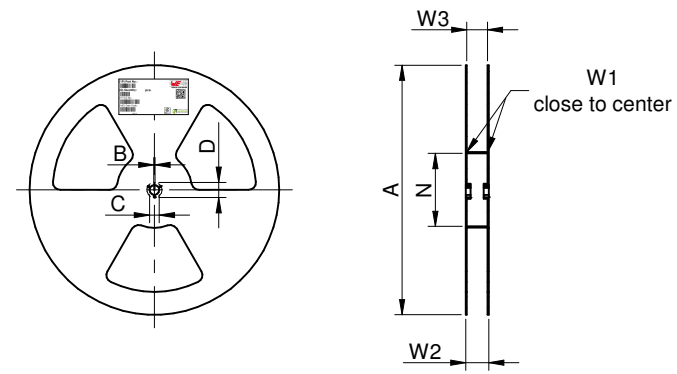
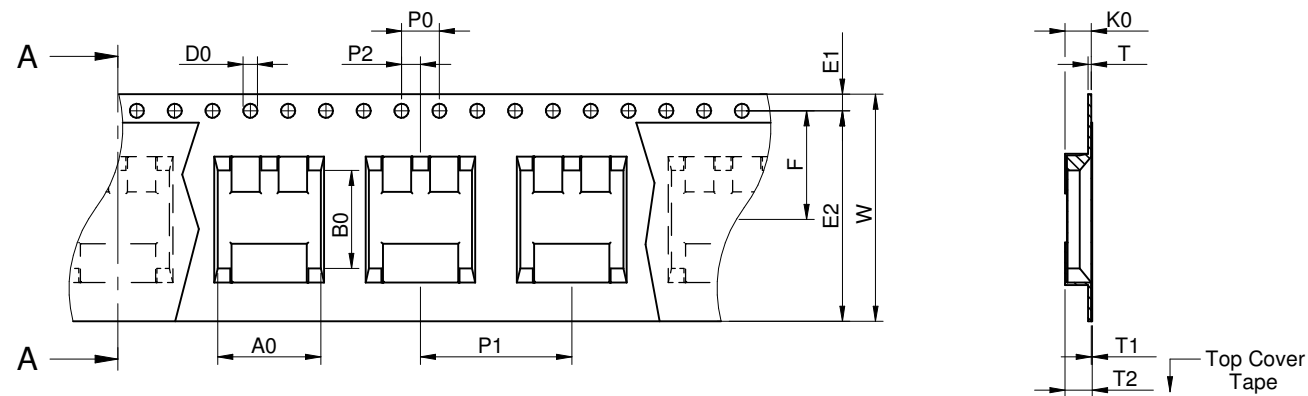
### Typical Temperature Rise vs. Current Characteristics:

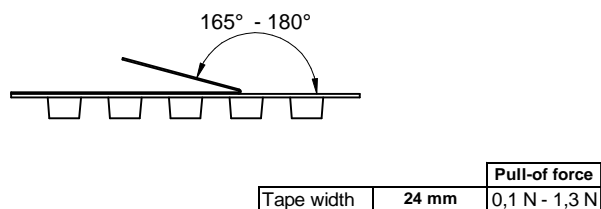

#### Product specific:

#### Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- All other soldering methods are at the customers' own risk.

#### Cleaning and Washing:



#### Packaging:


