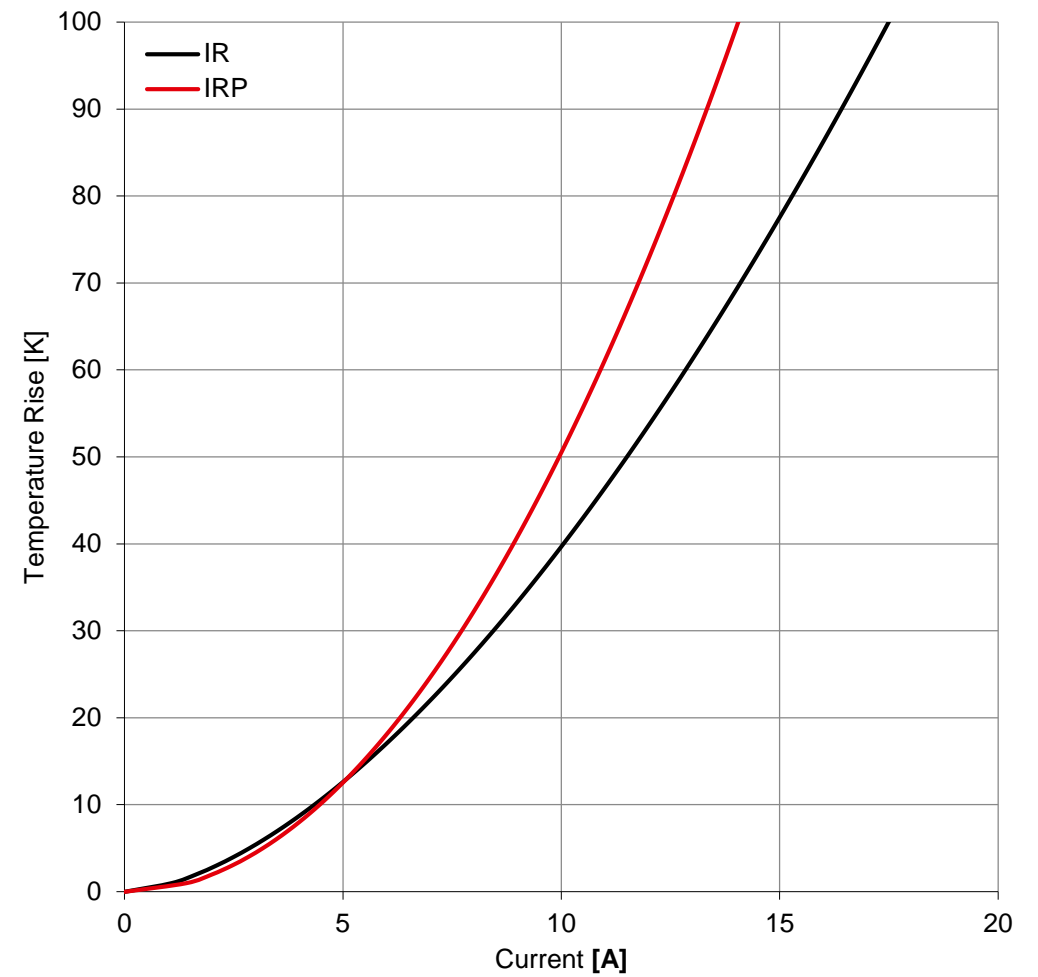

### Typical Temperature Rise vs. Current Characteristics:

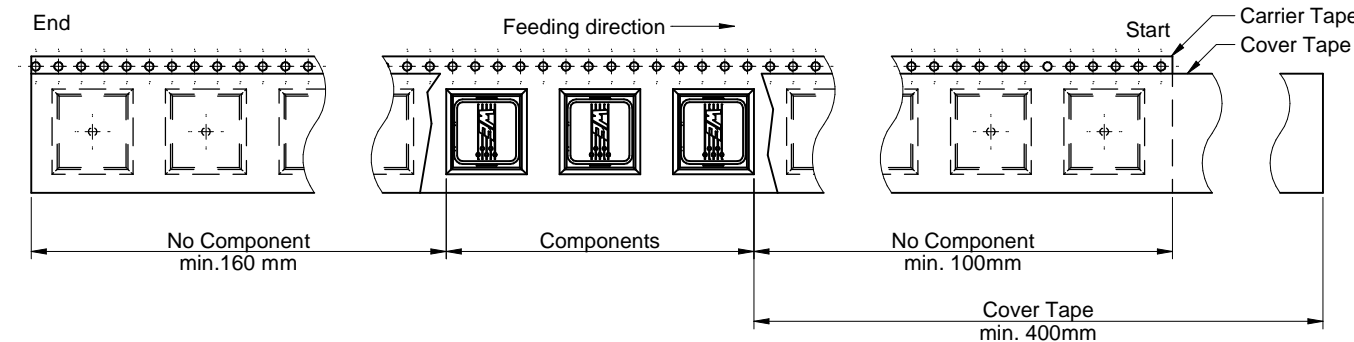
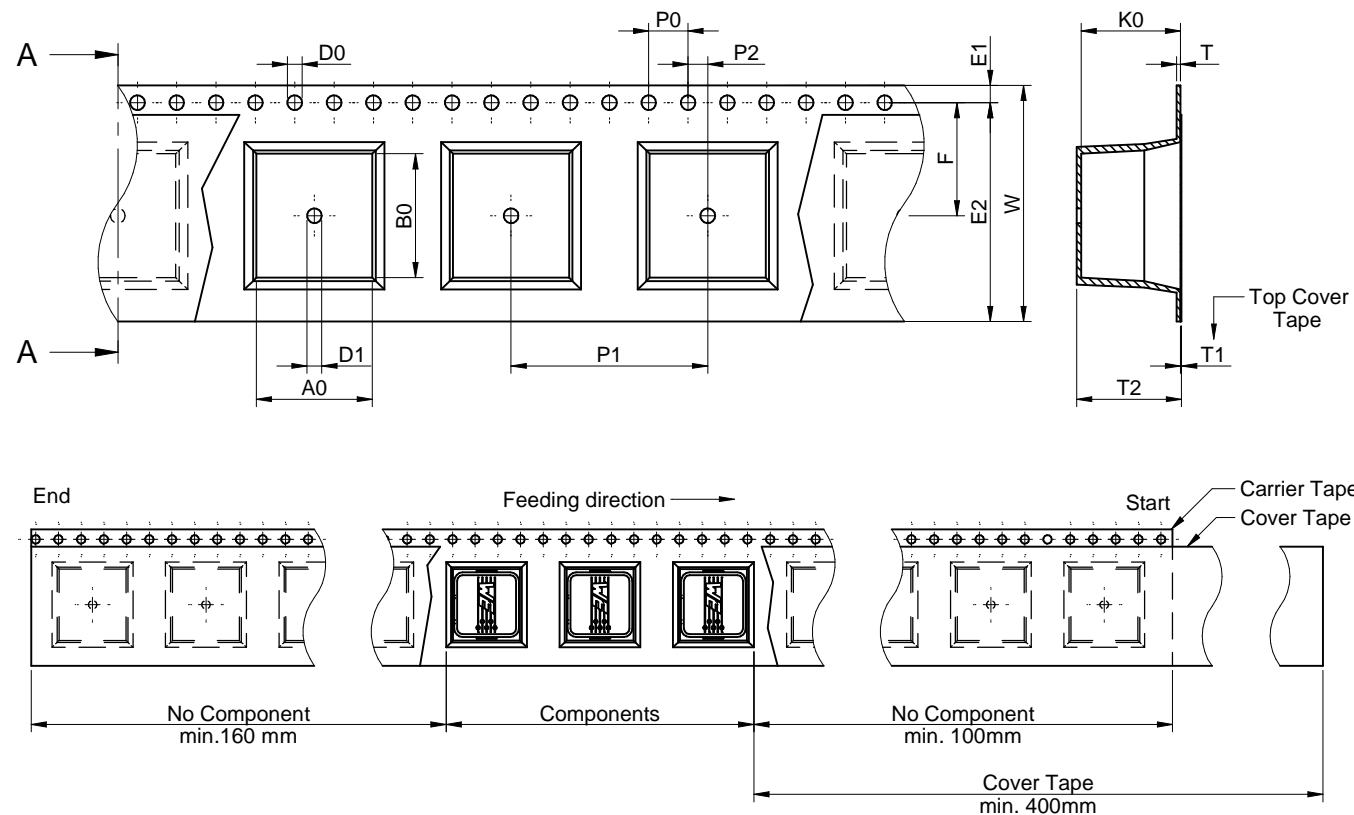

#### Soldering:




