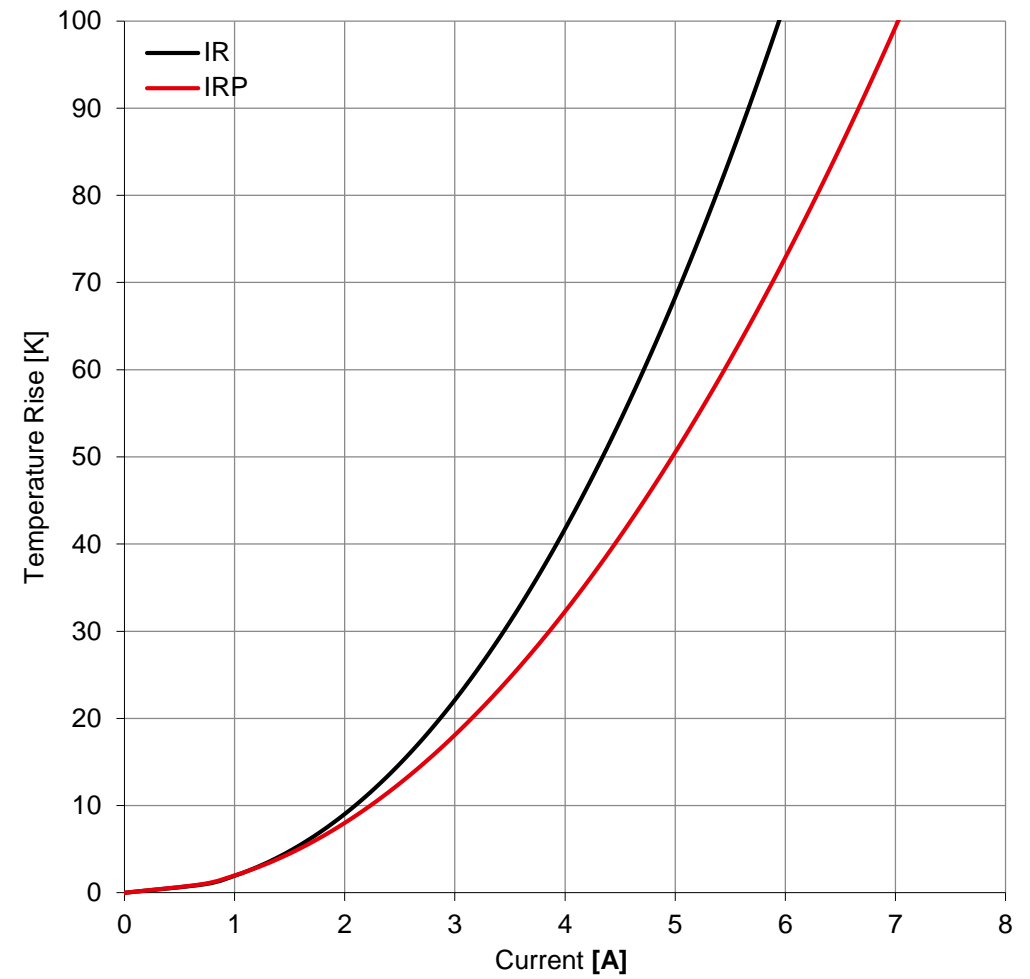

Soldering:




