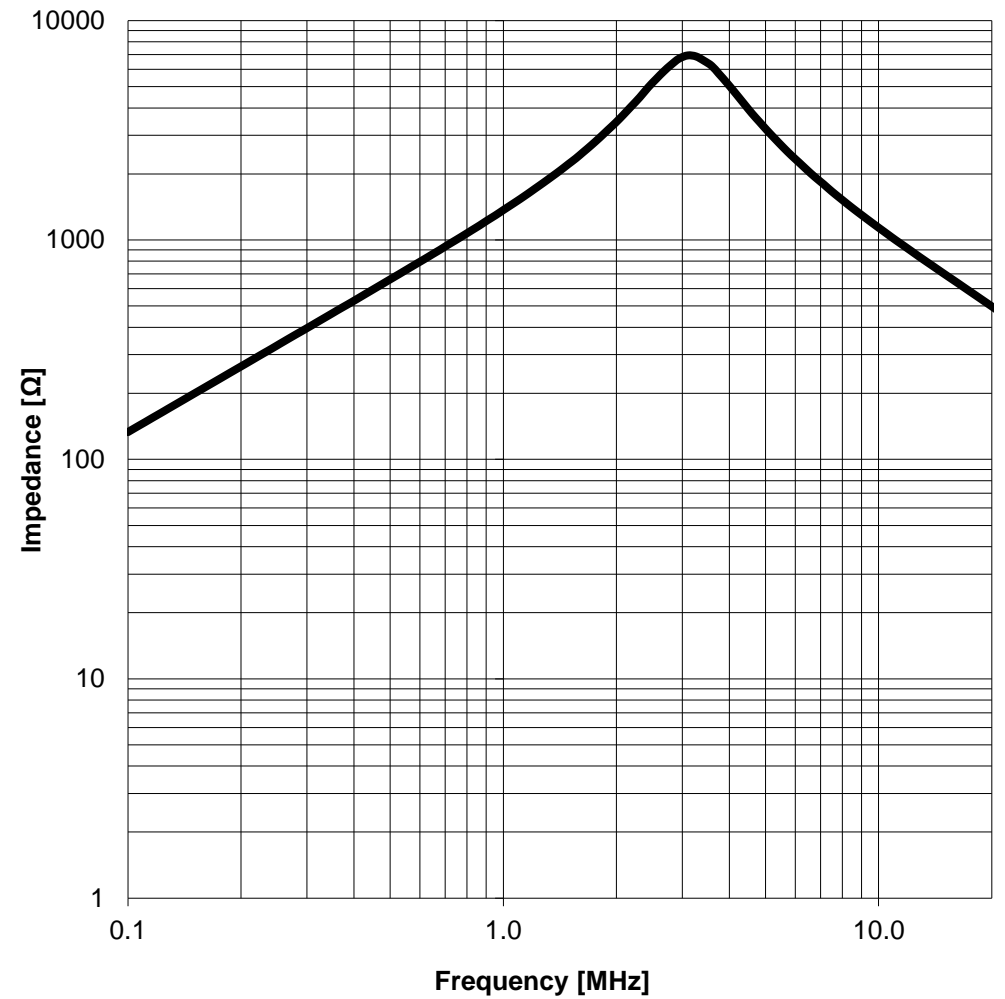



#### Packaging:


