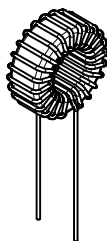
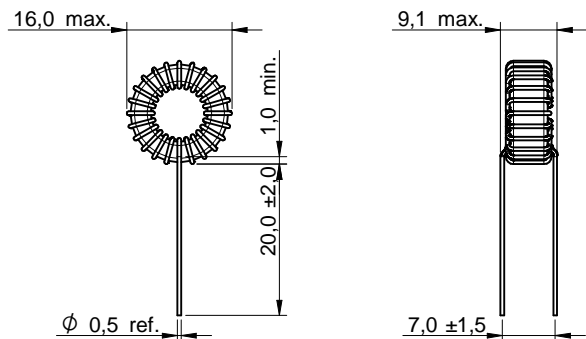
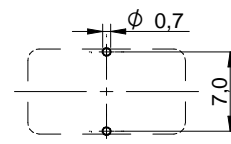

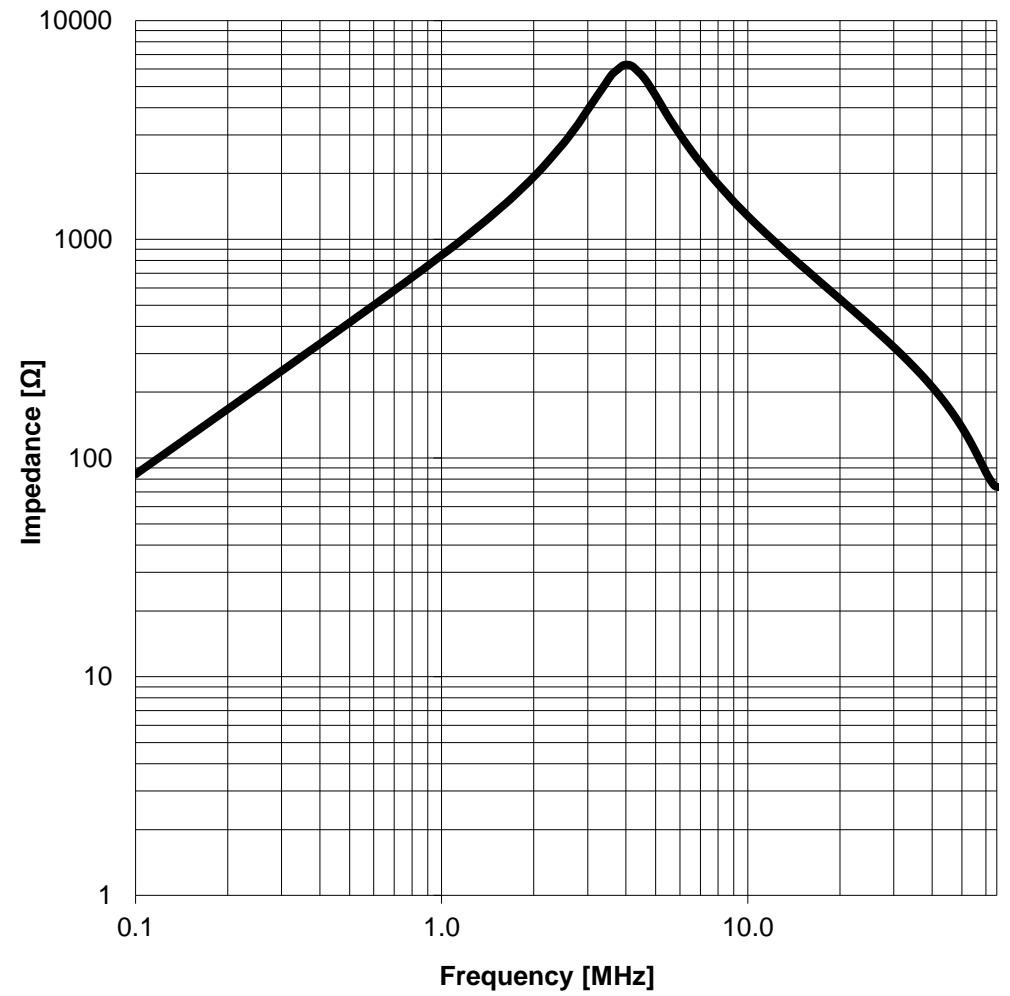

Soldering:



Packaging:


