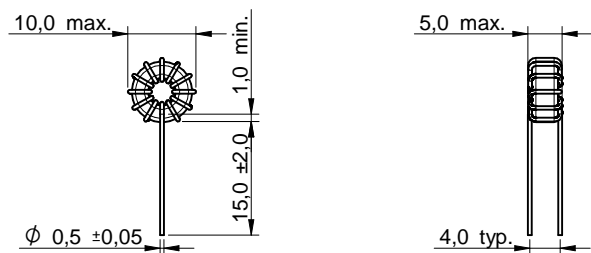

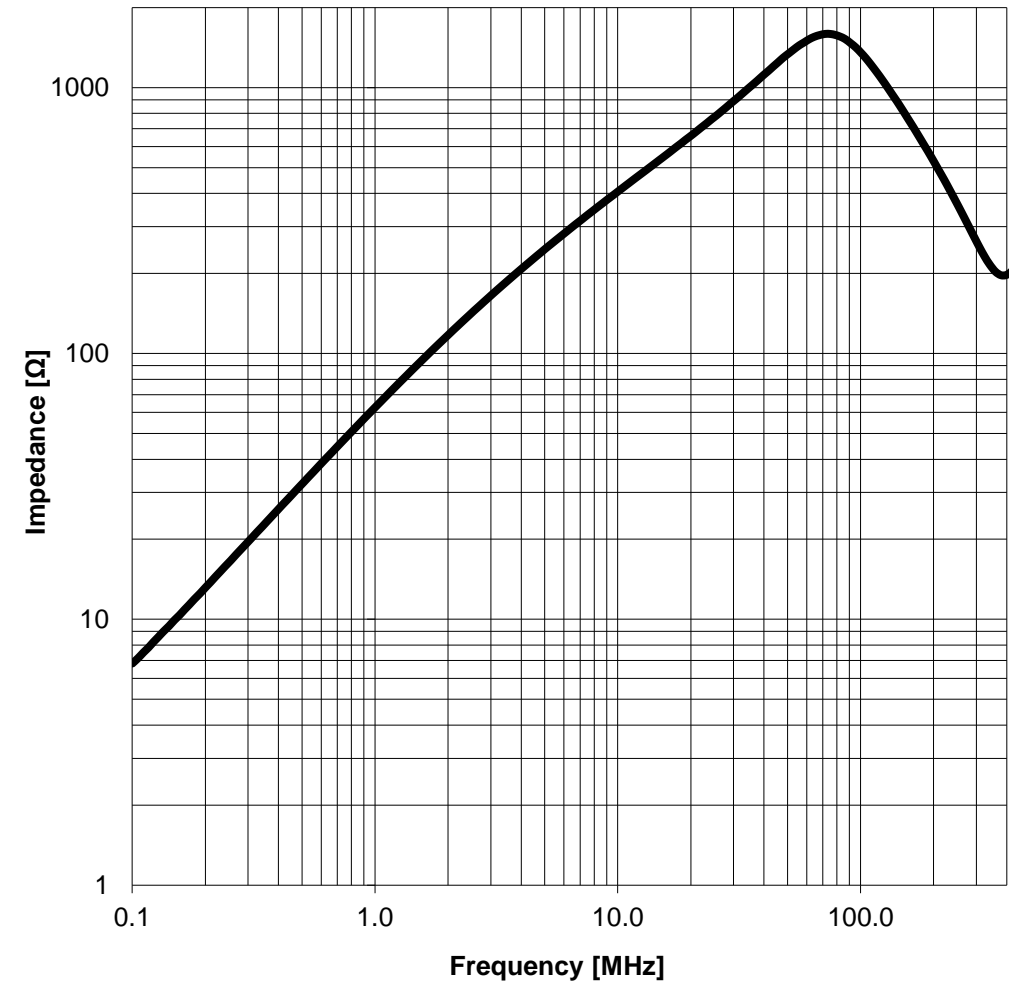





#### Packaging:


