**sectional drawing A-A**

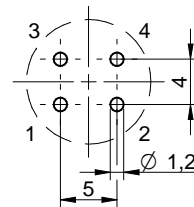

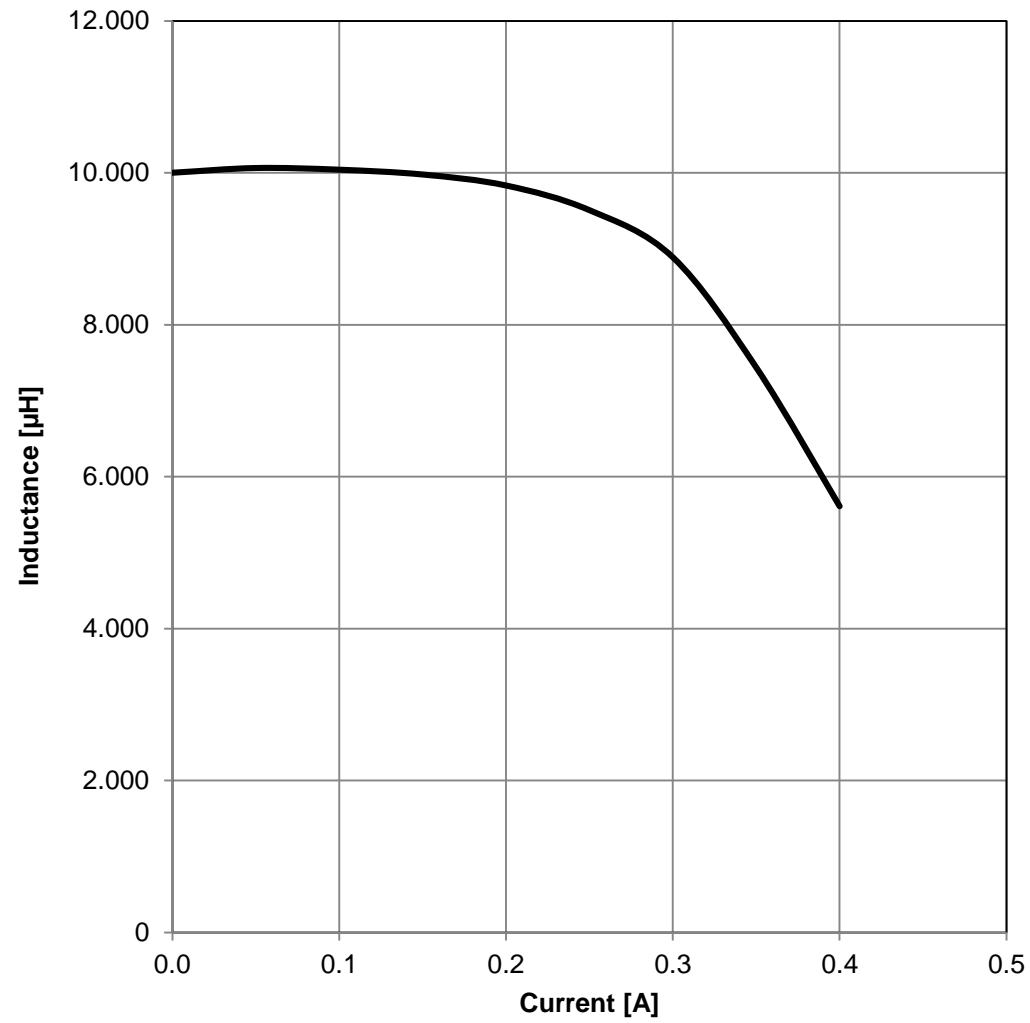

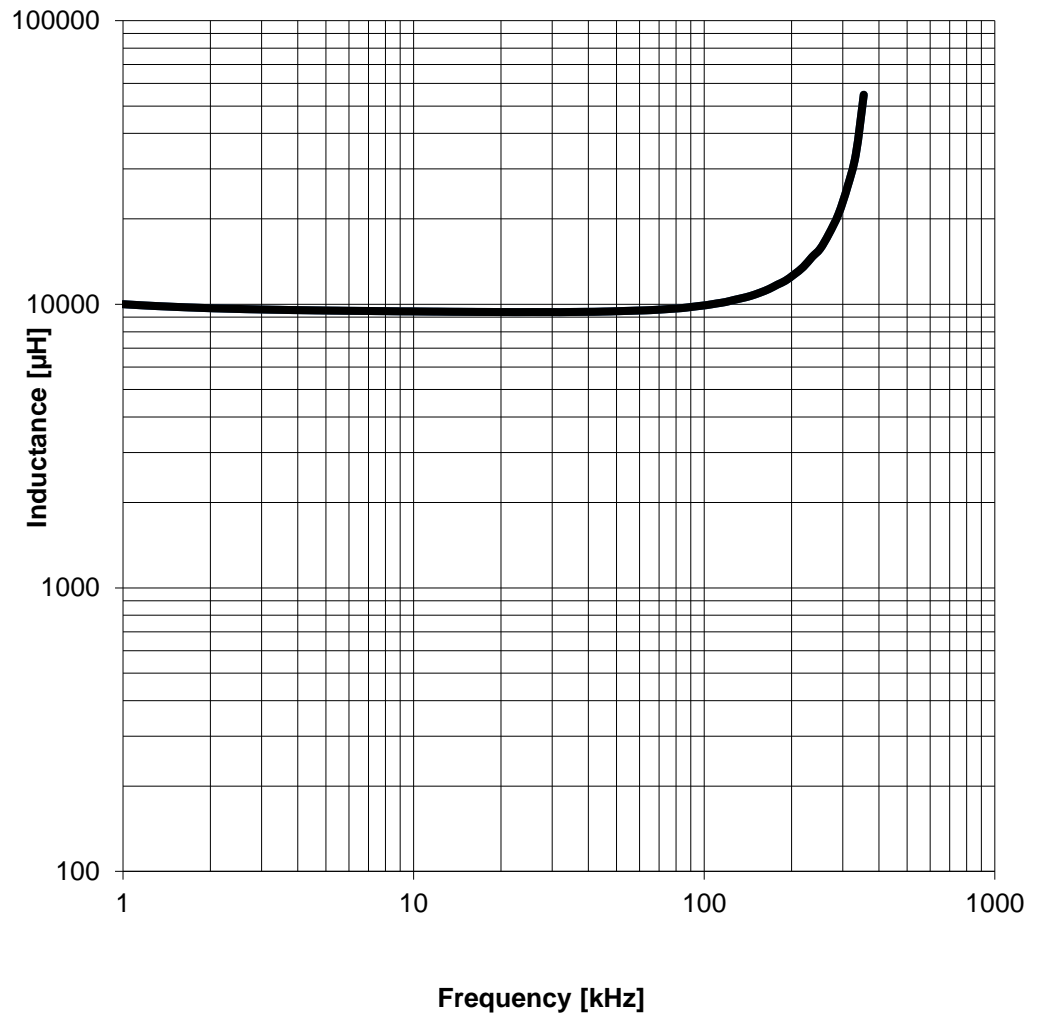

### Typical Inductance vs. Frequency Characteristics:

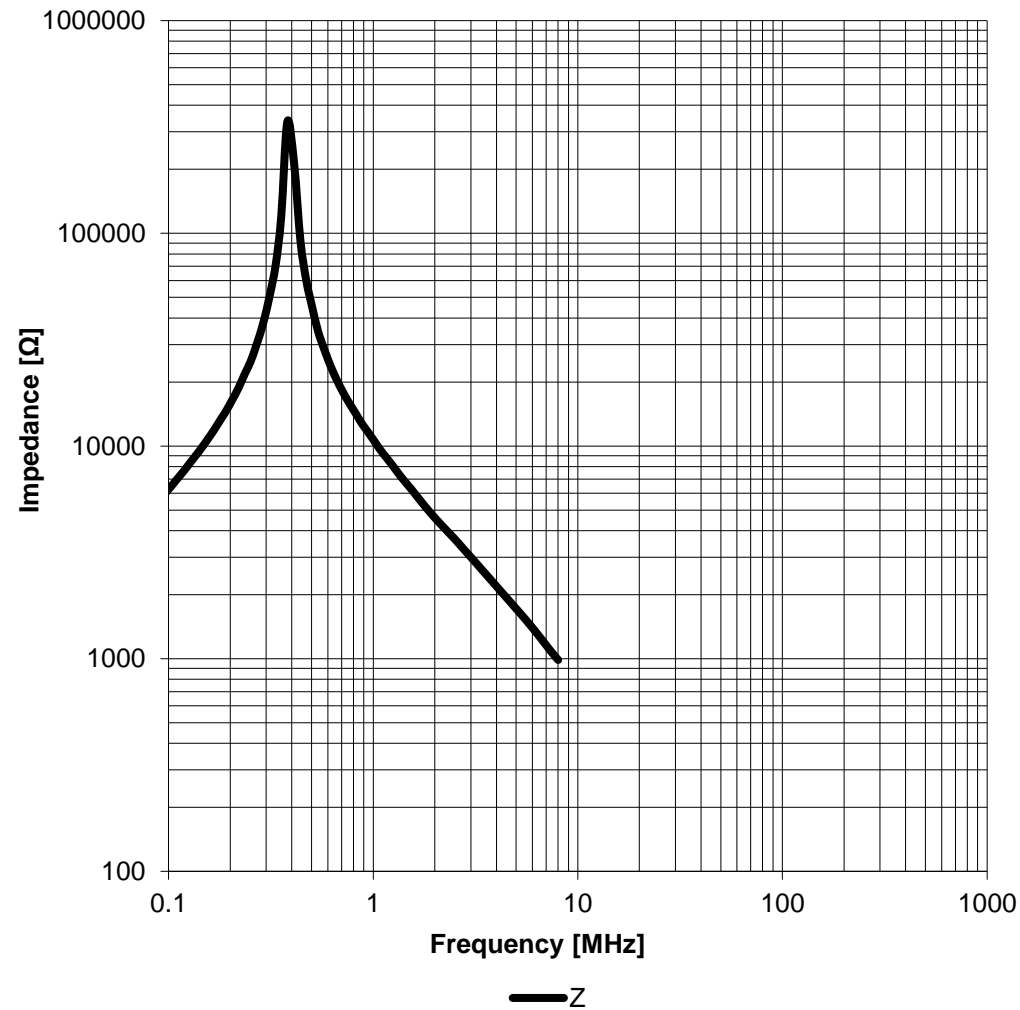
