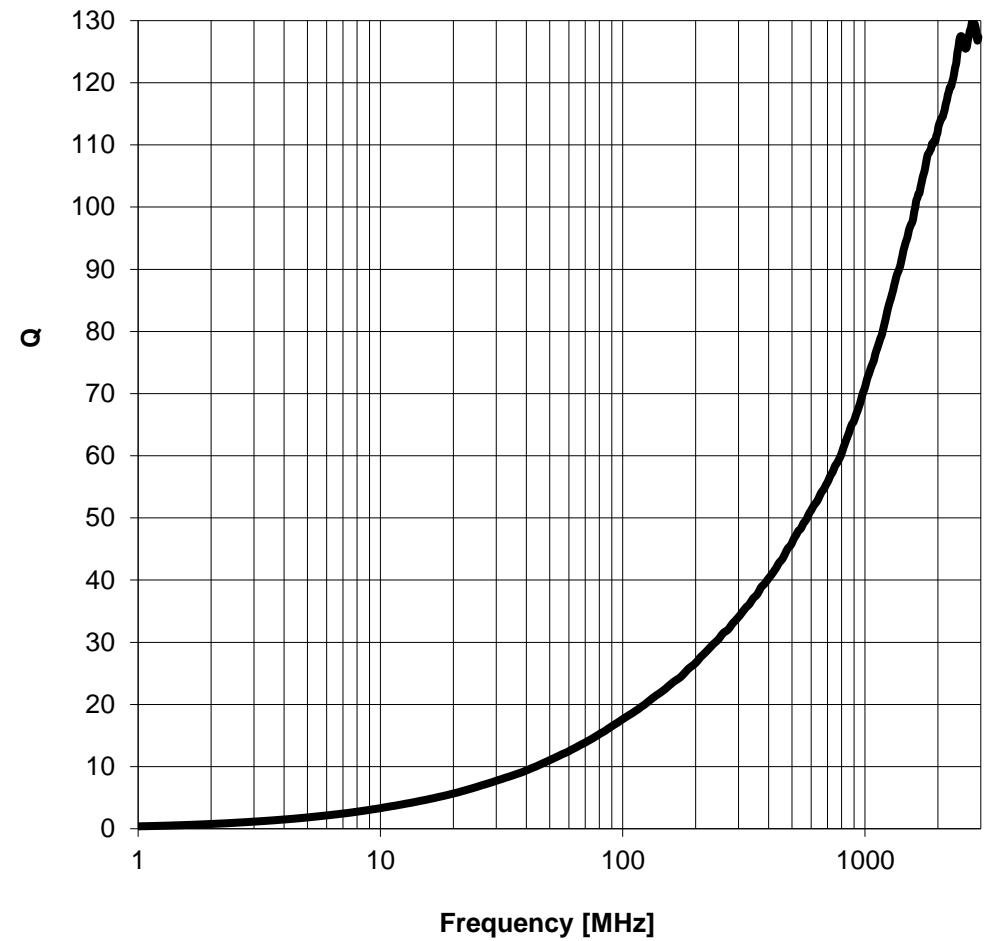

Q-Factor vs. Frequency:

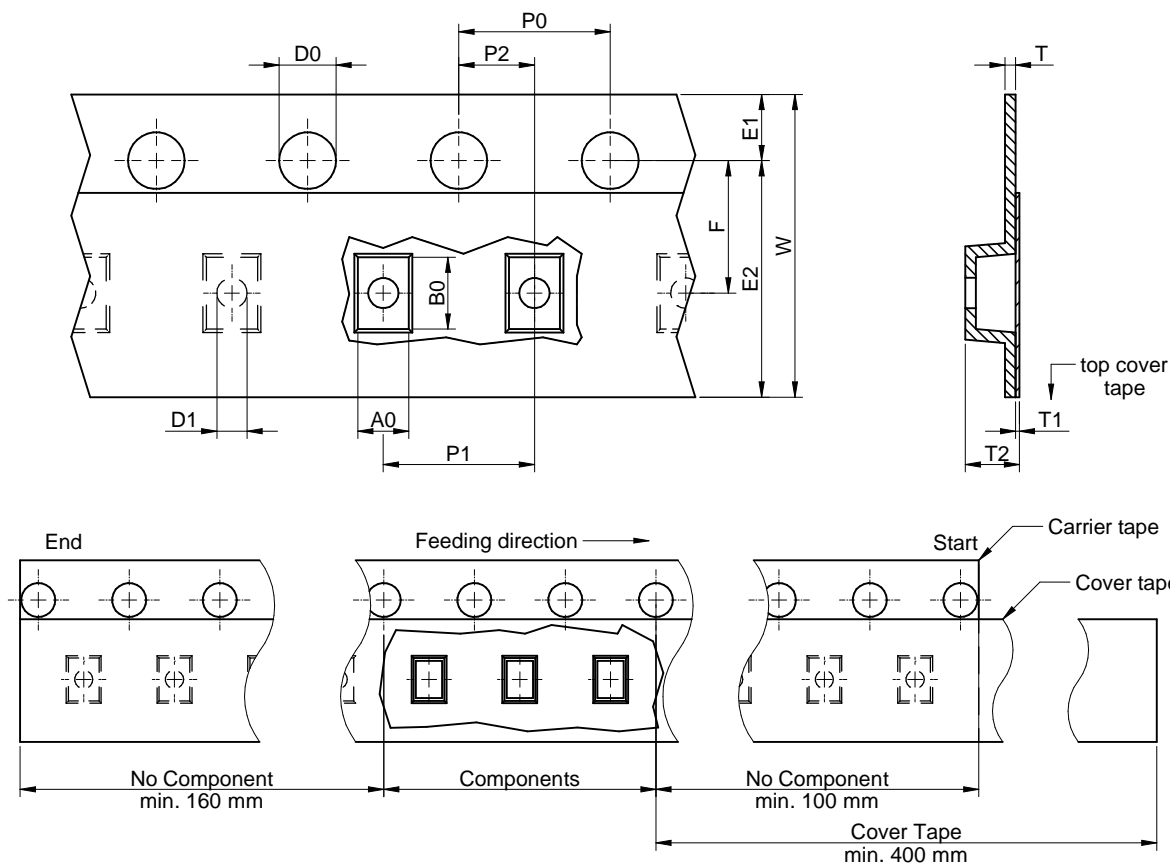

Soldering:




