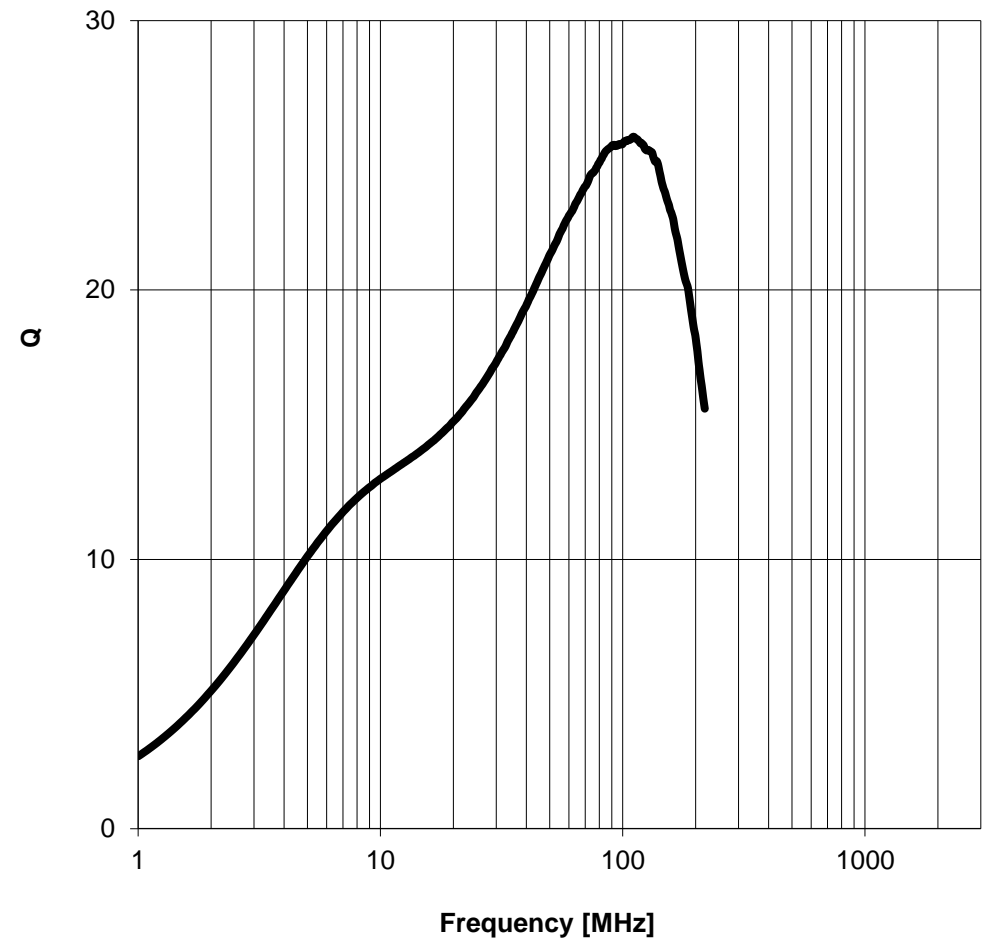

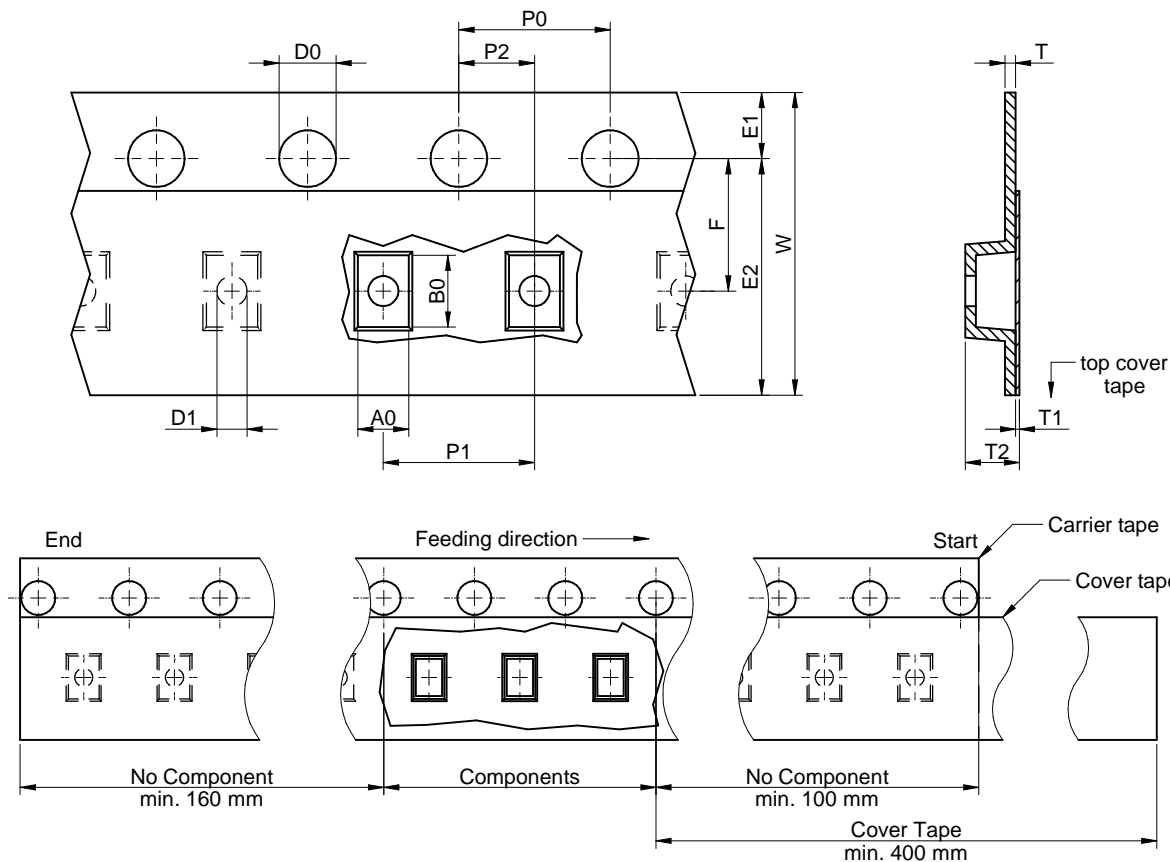

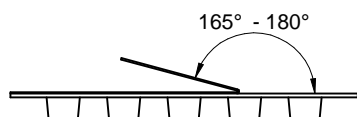

#### Soldering:




