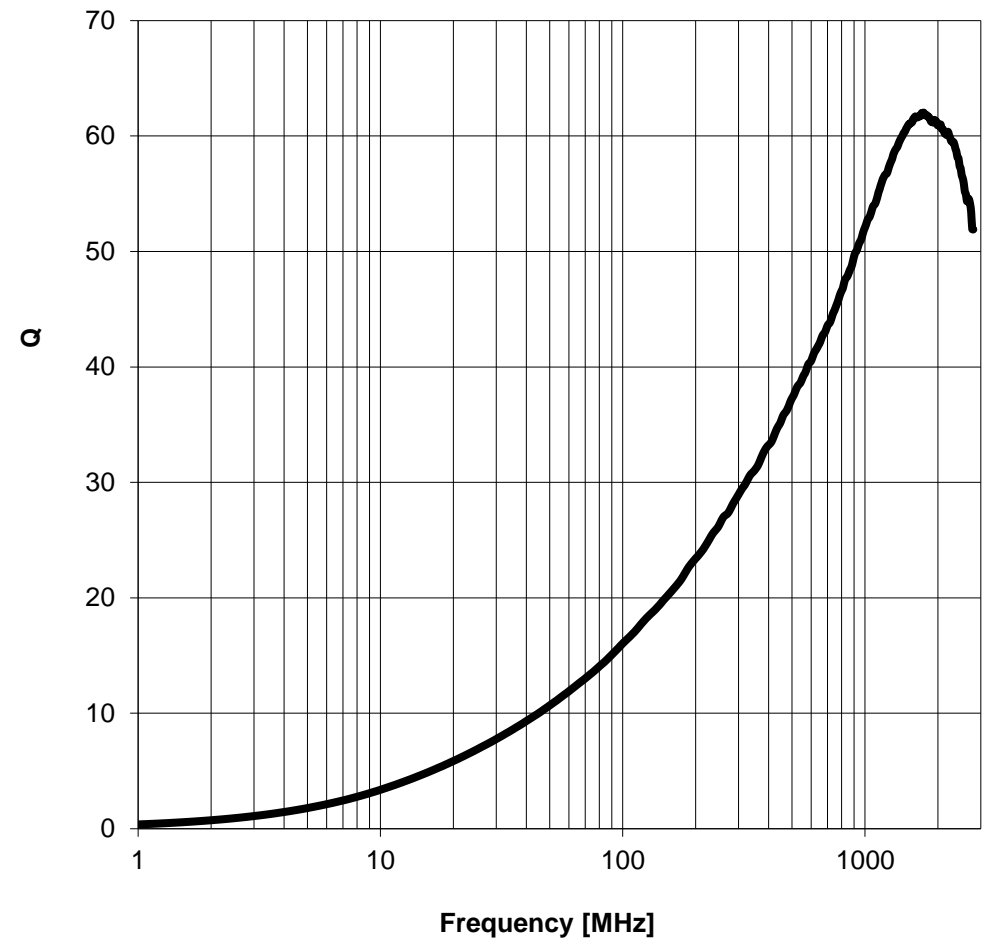

#### Soldering:




