### Typical Inductance vs. Current Characteristics:



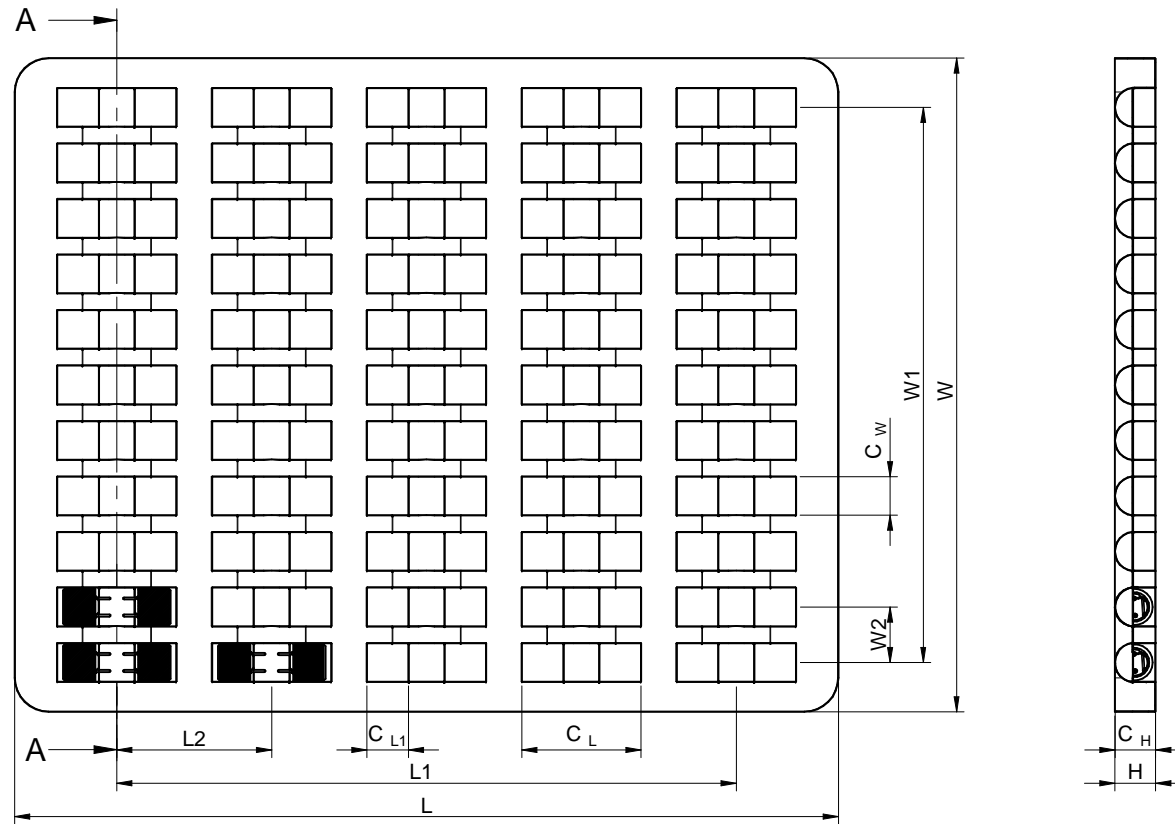



## Storage Conditions:


