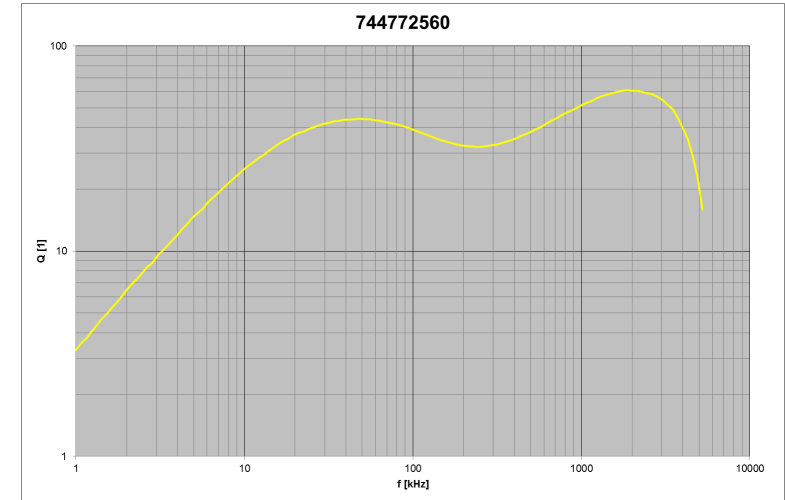

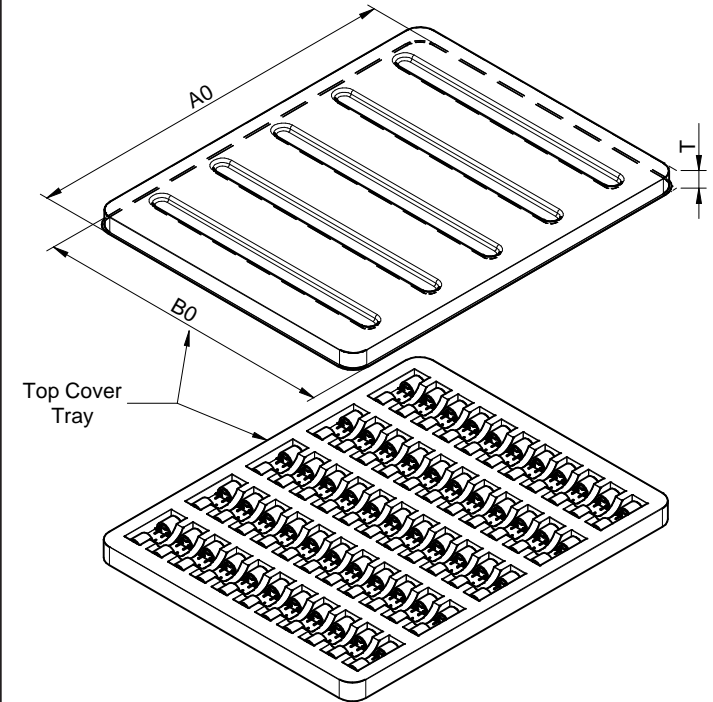
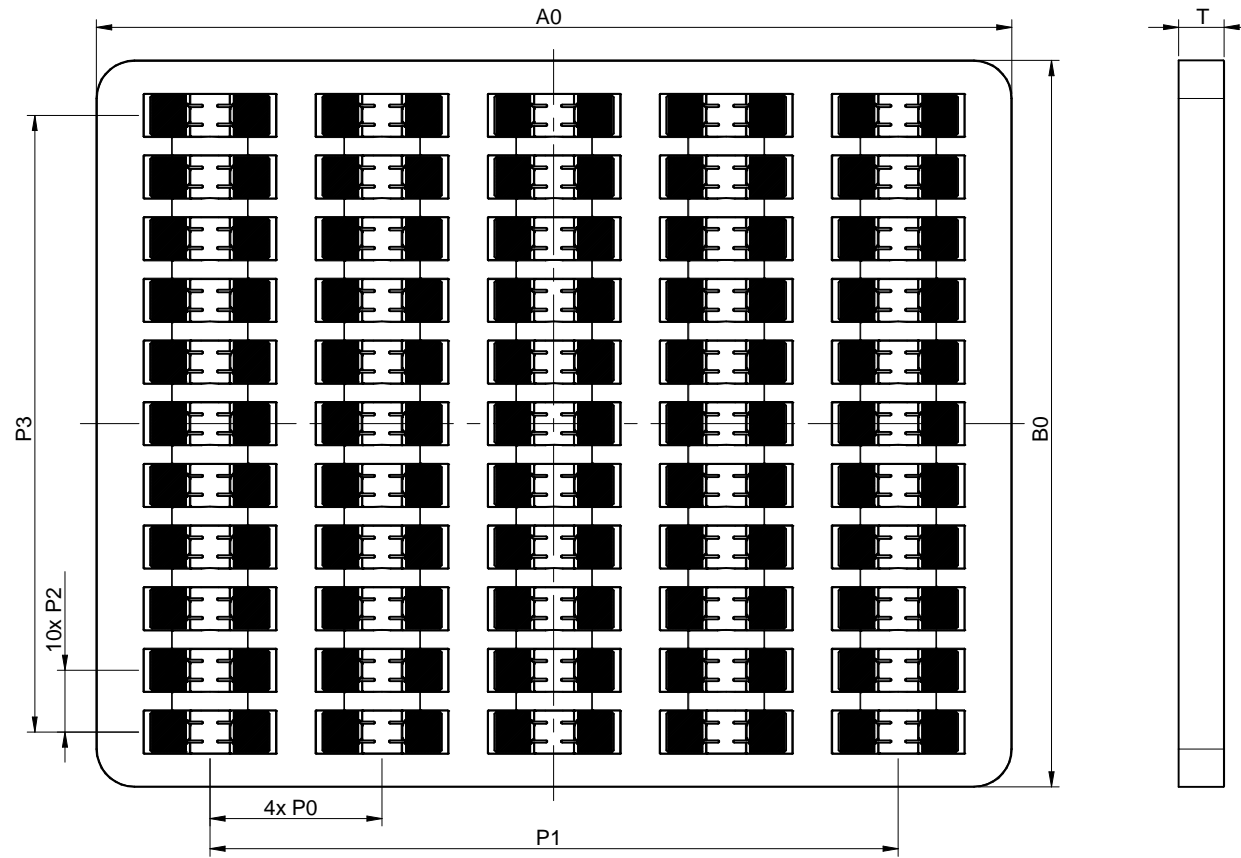
Typical Impedance Characteristics:






