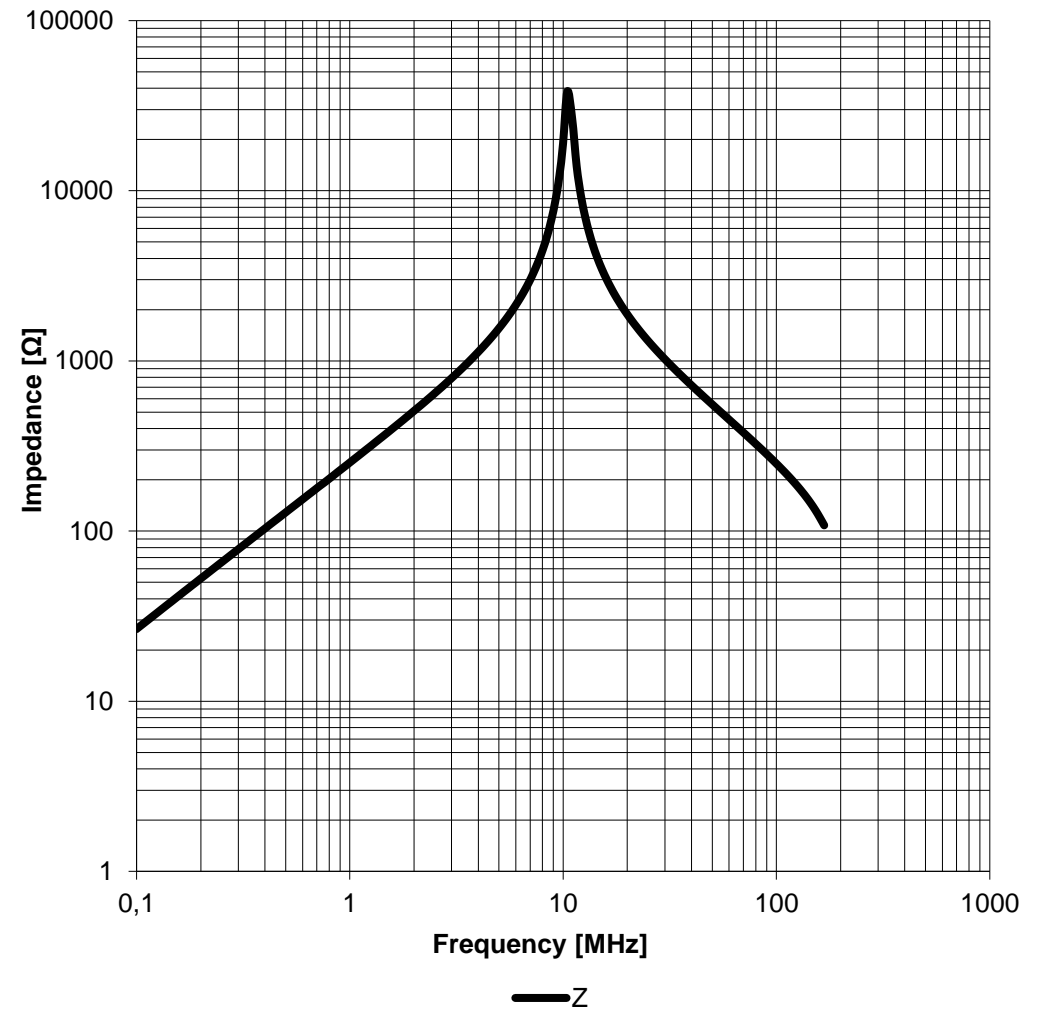

Typical Inductance vs. Current Characteristics:



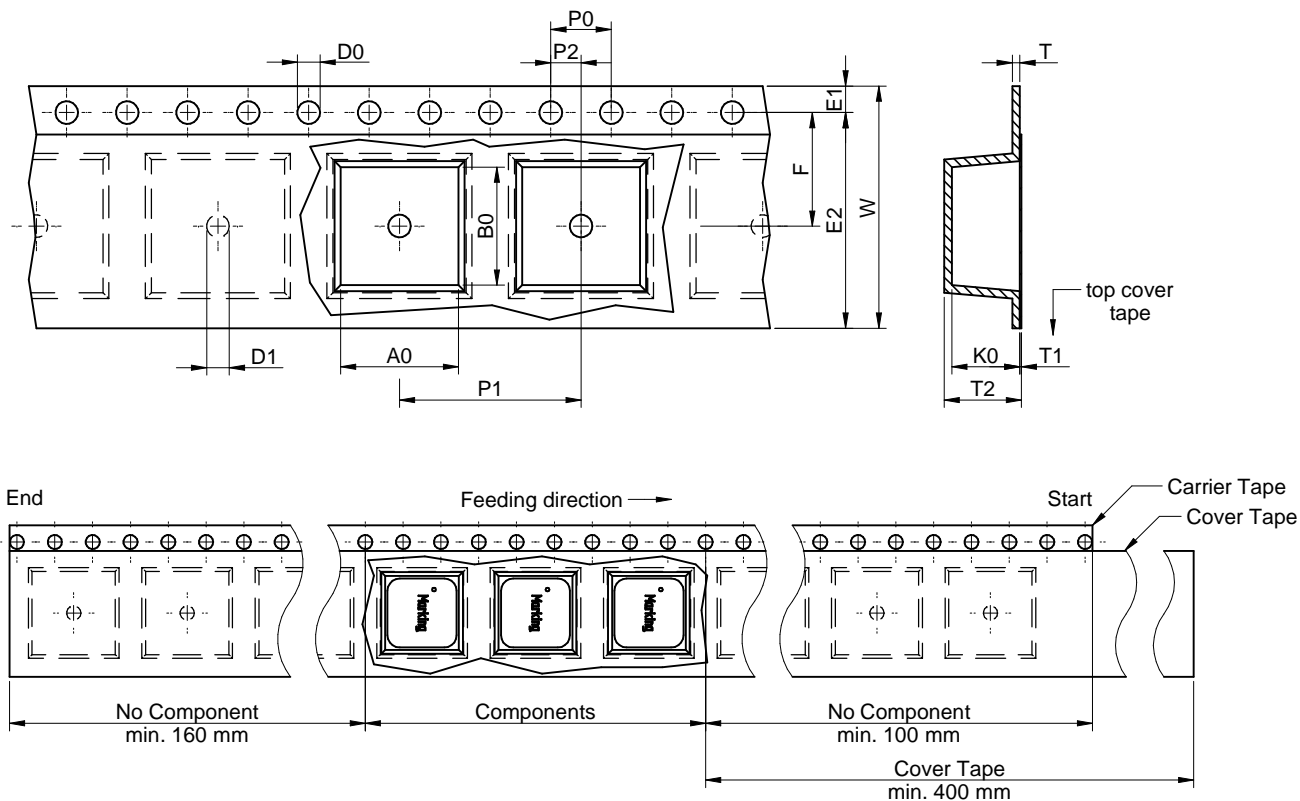
Typical Impedance Characteristics:

Soldering:



Storage Conditions:


