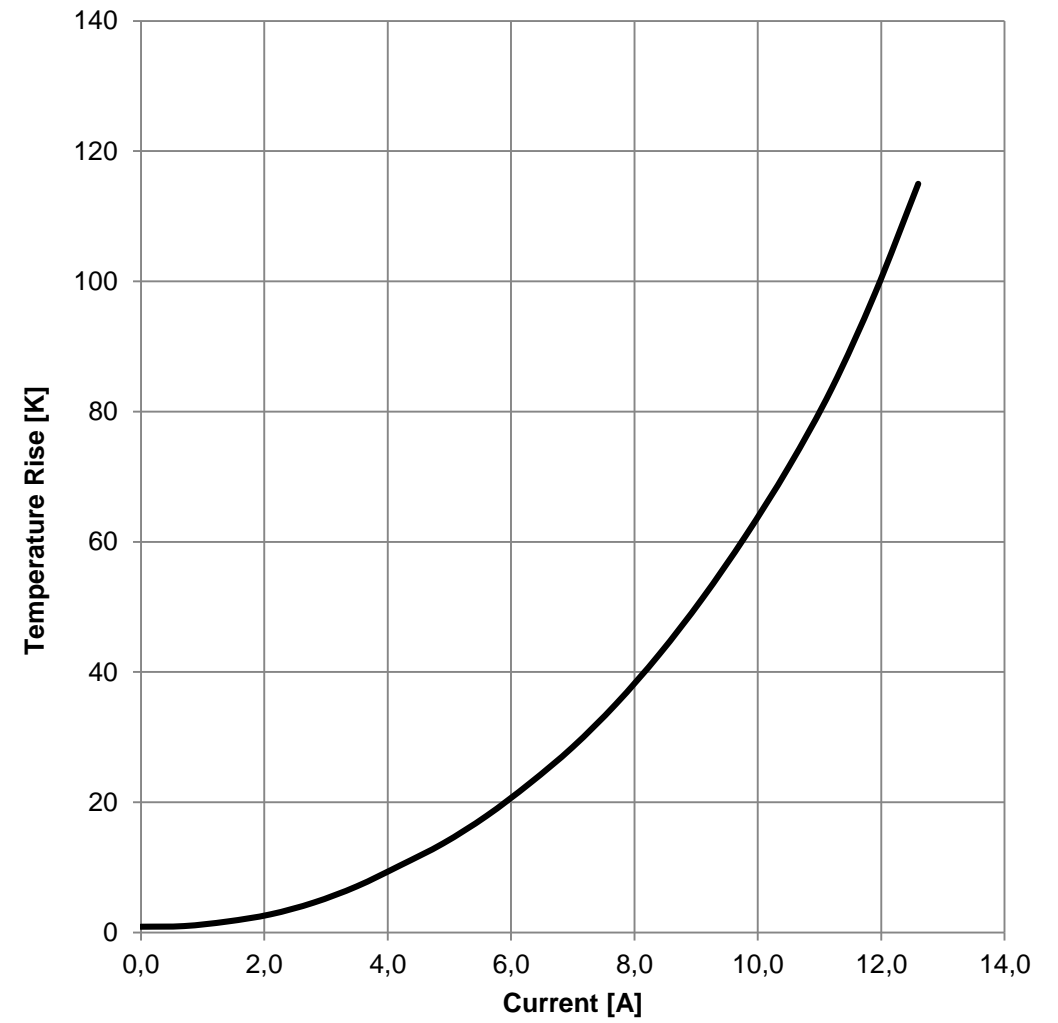

### Typical Inductance vs. Current Characteristics:



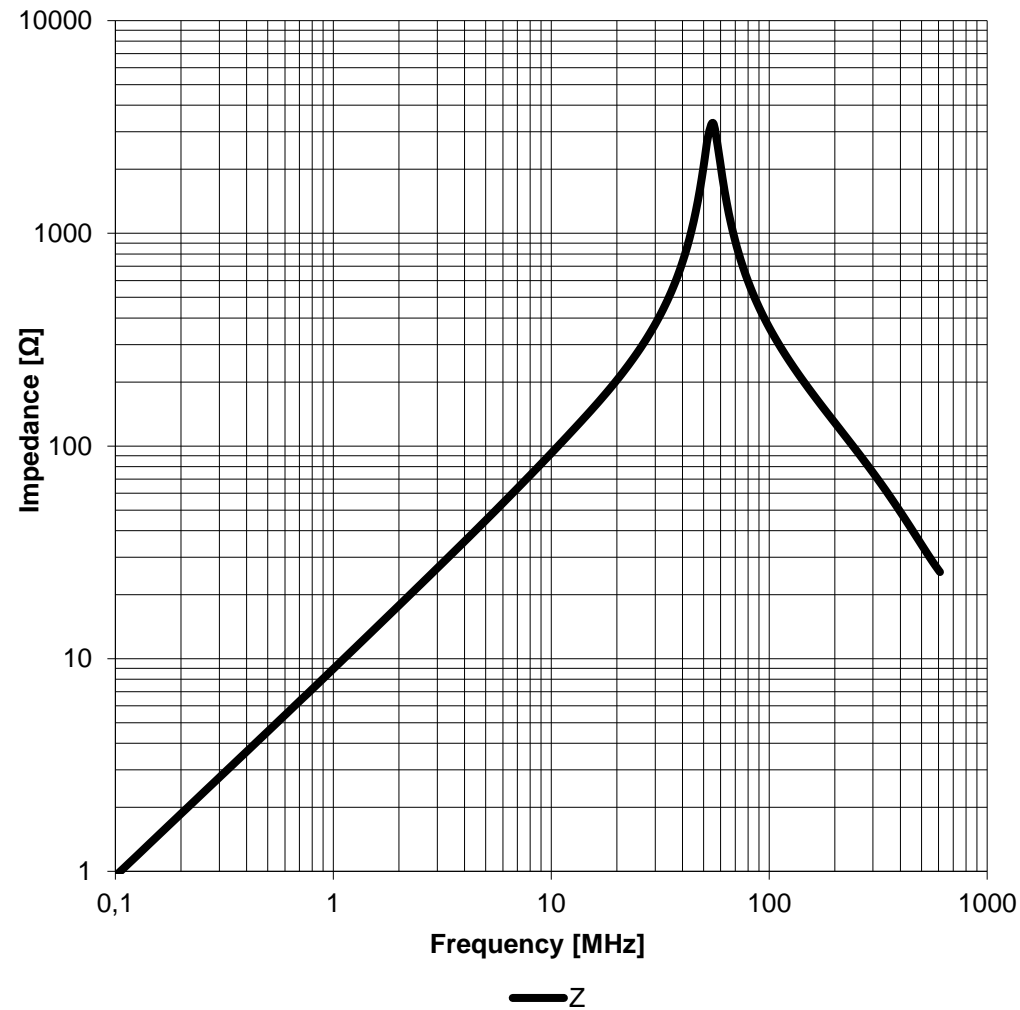
### Typical Temperature Rise vs. Current Characteristics:

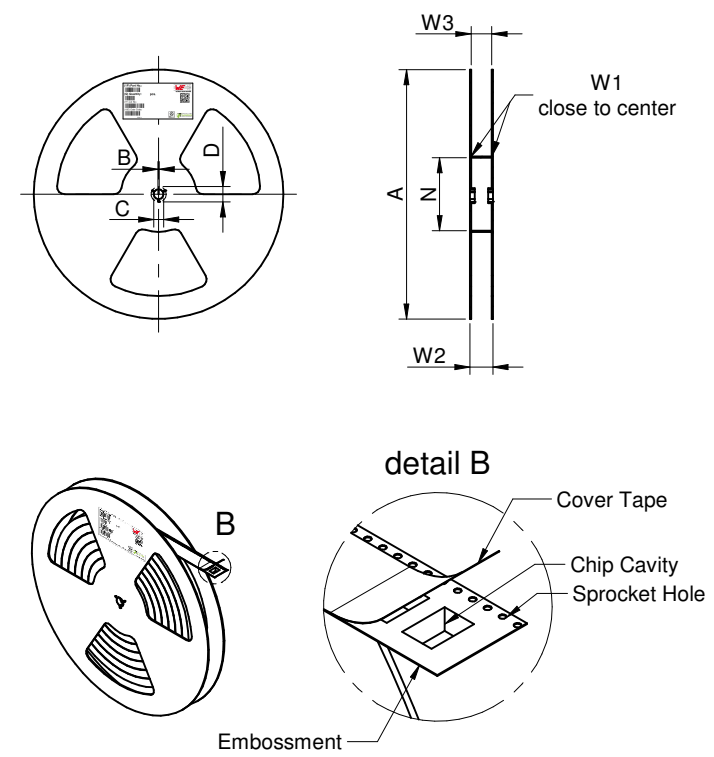
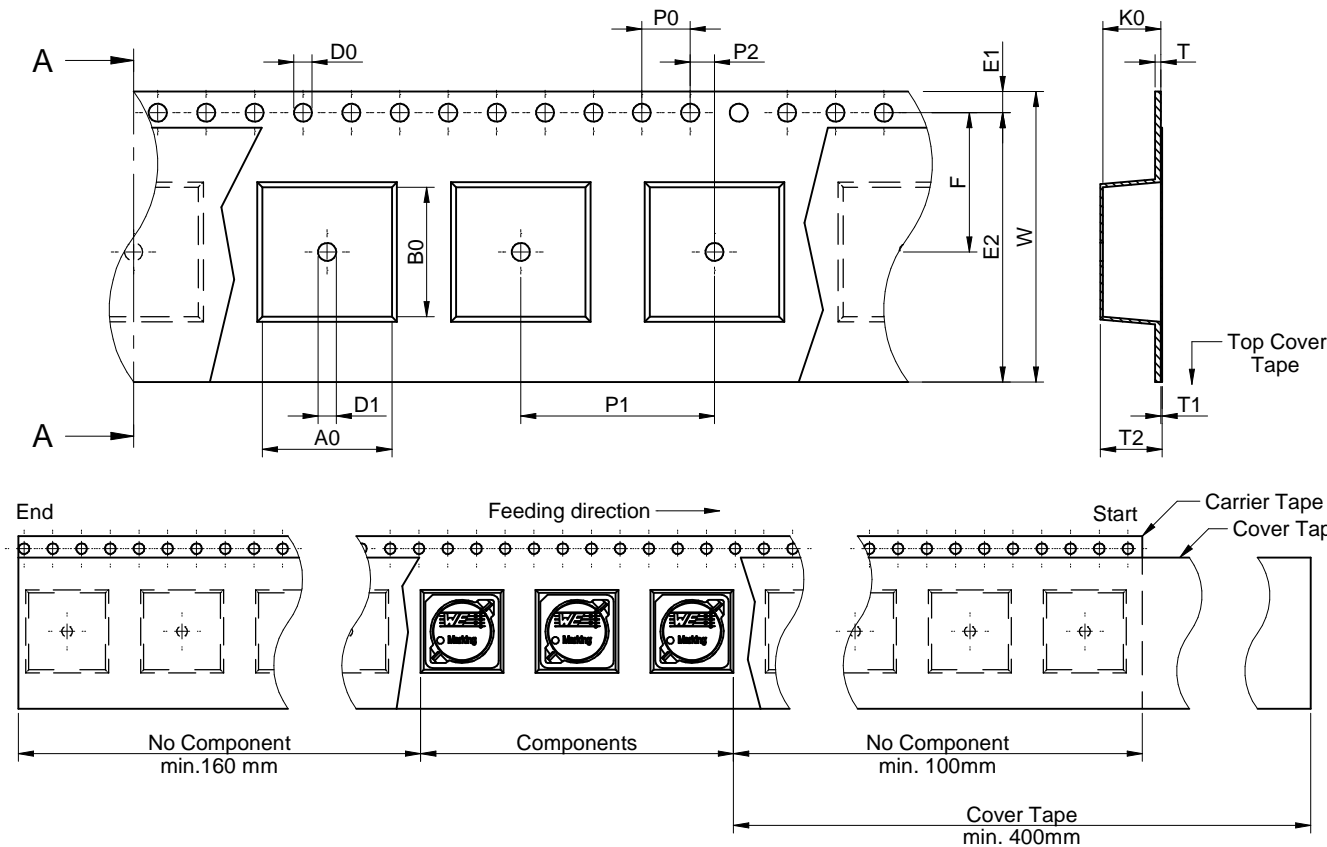
**Typical Impedance Characteristics:**

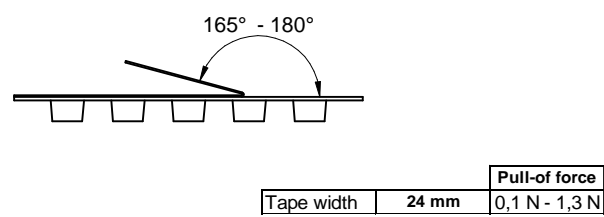

#### Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.



#### Packaging:

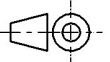
