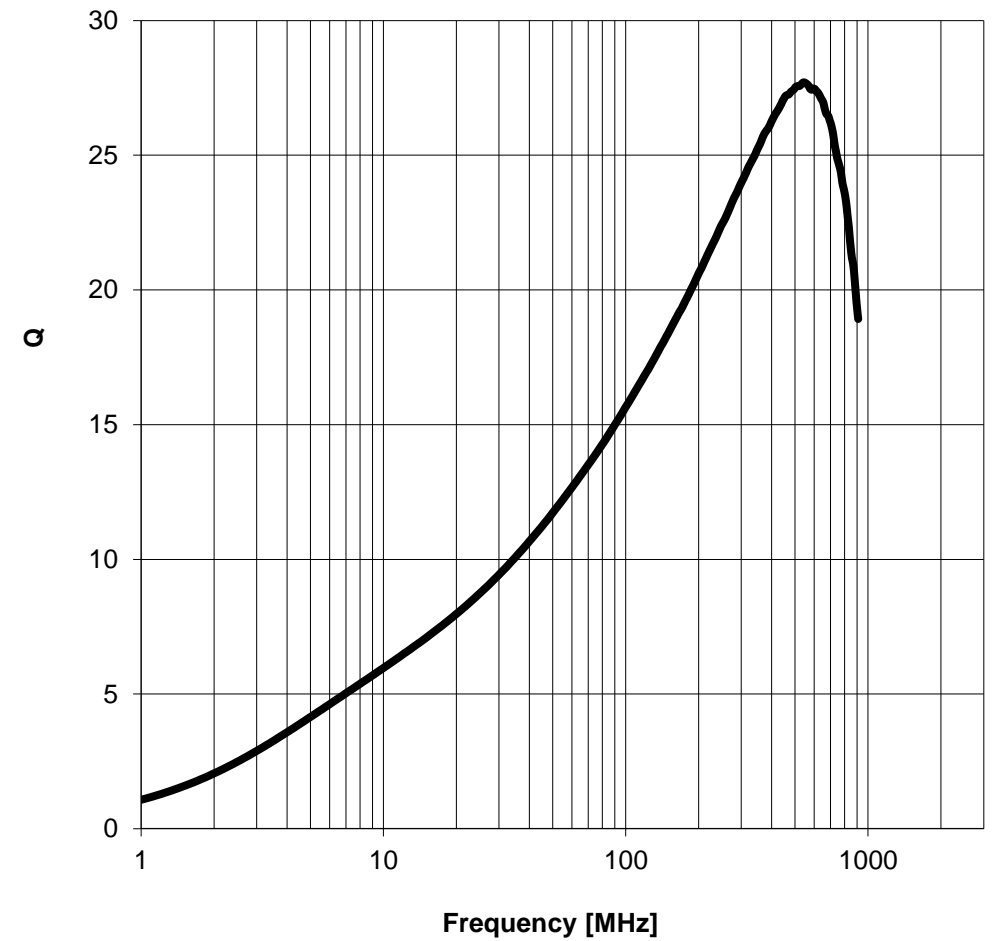



Soldering:




