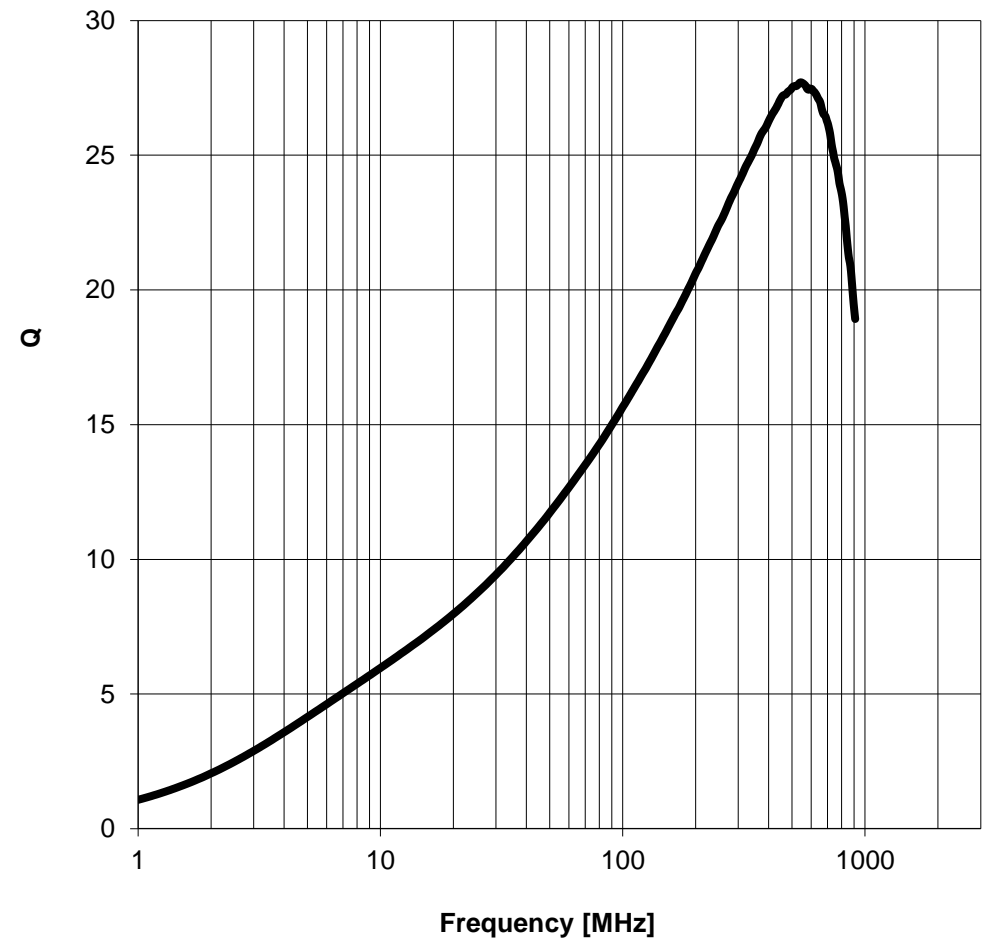



Soldering:




