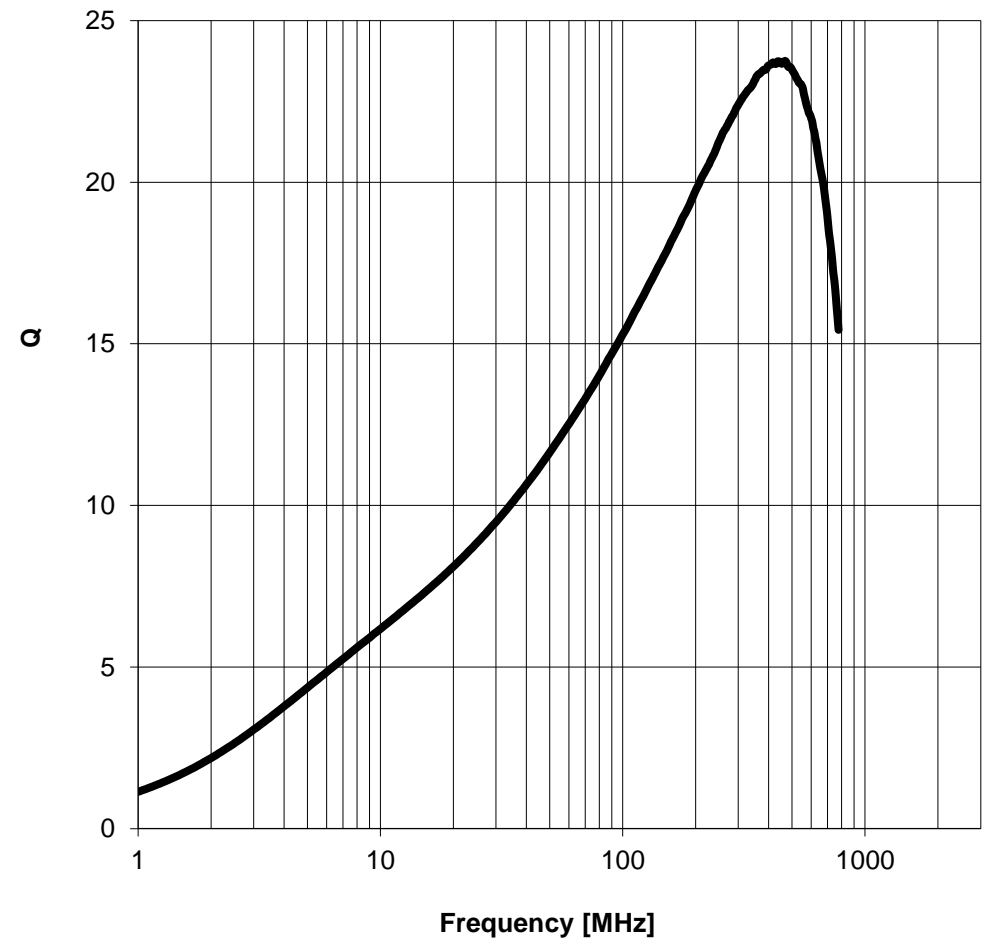



Soldering:




