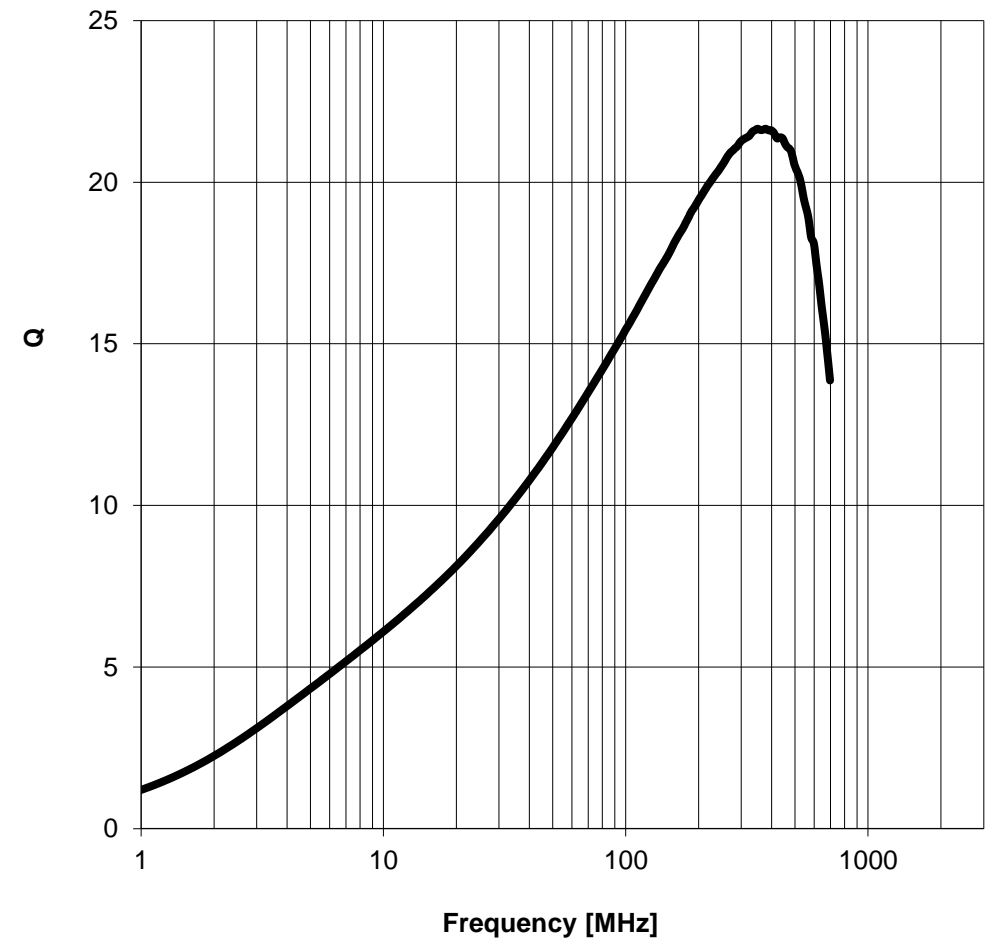



Soldering:




