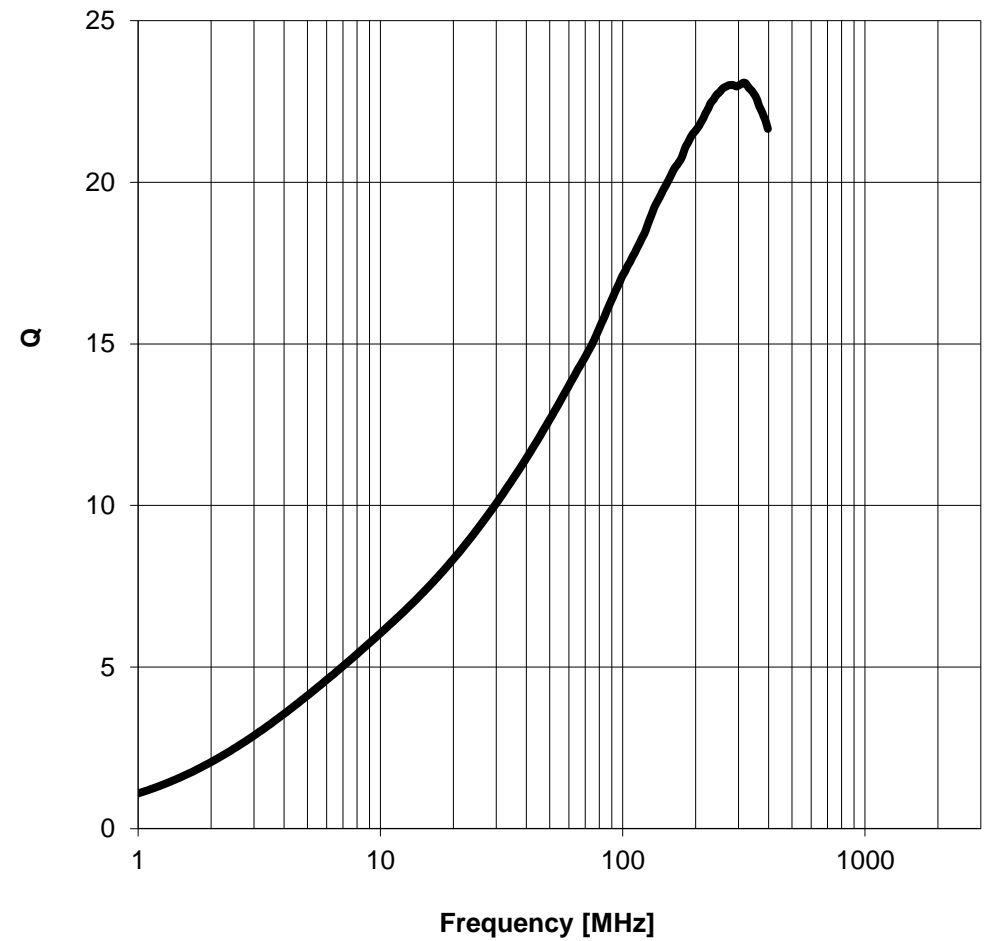


## Storage Conditions:


