### Typical Inductance vs. Frequency Characteristics:



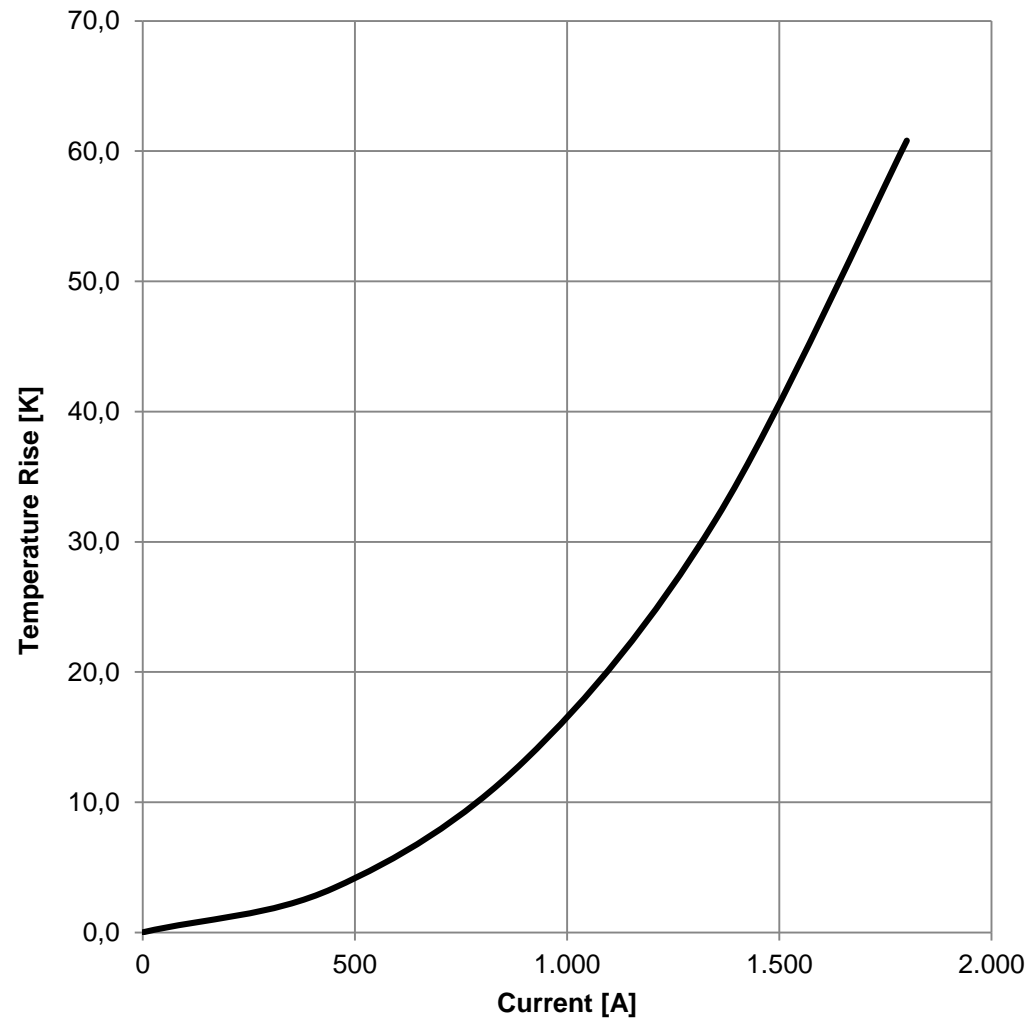

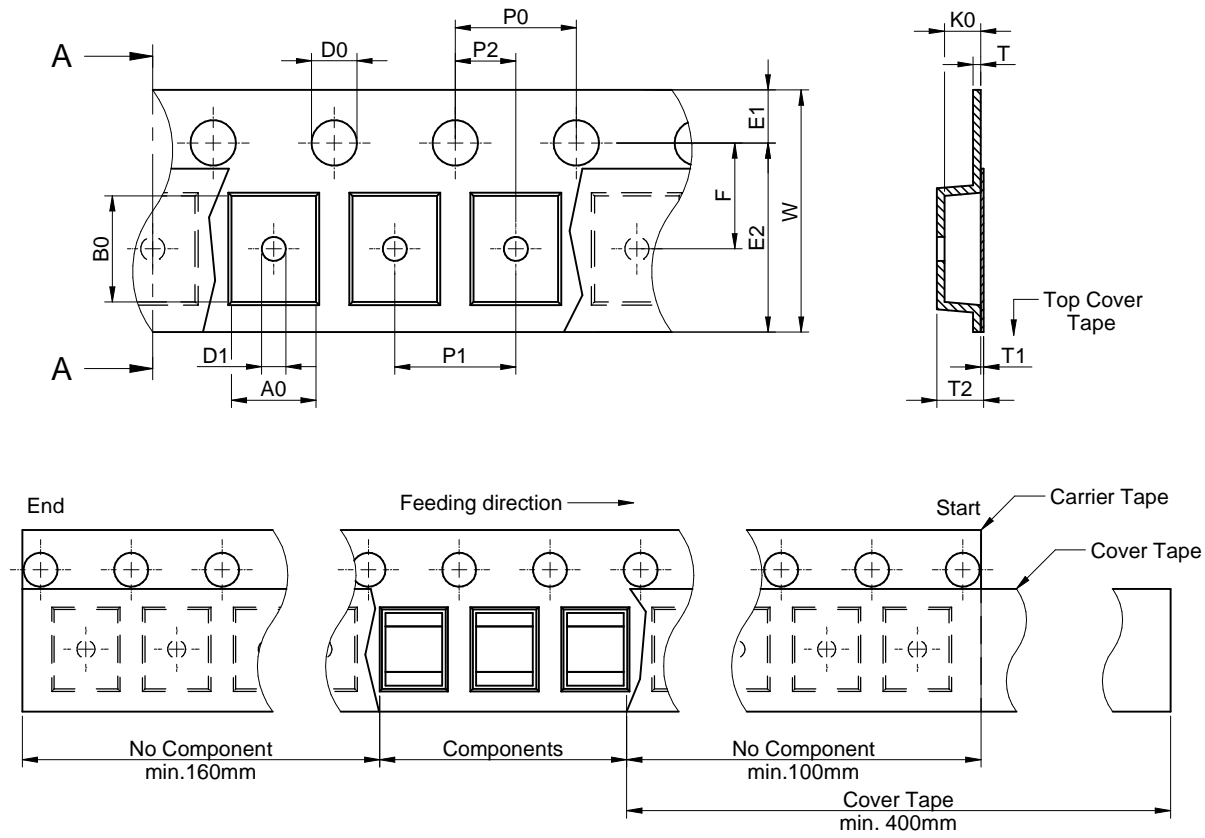
**Typical Temperature Rise vs. Current Characteristics:**

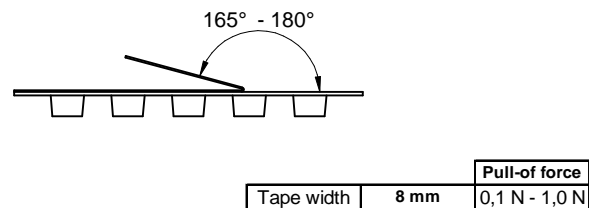




