### Typical Inductance vs. Frequency Characteristics:



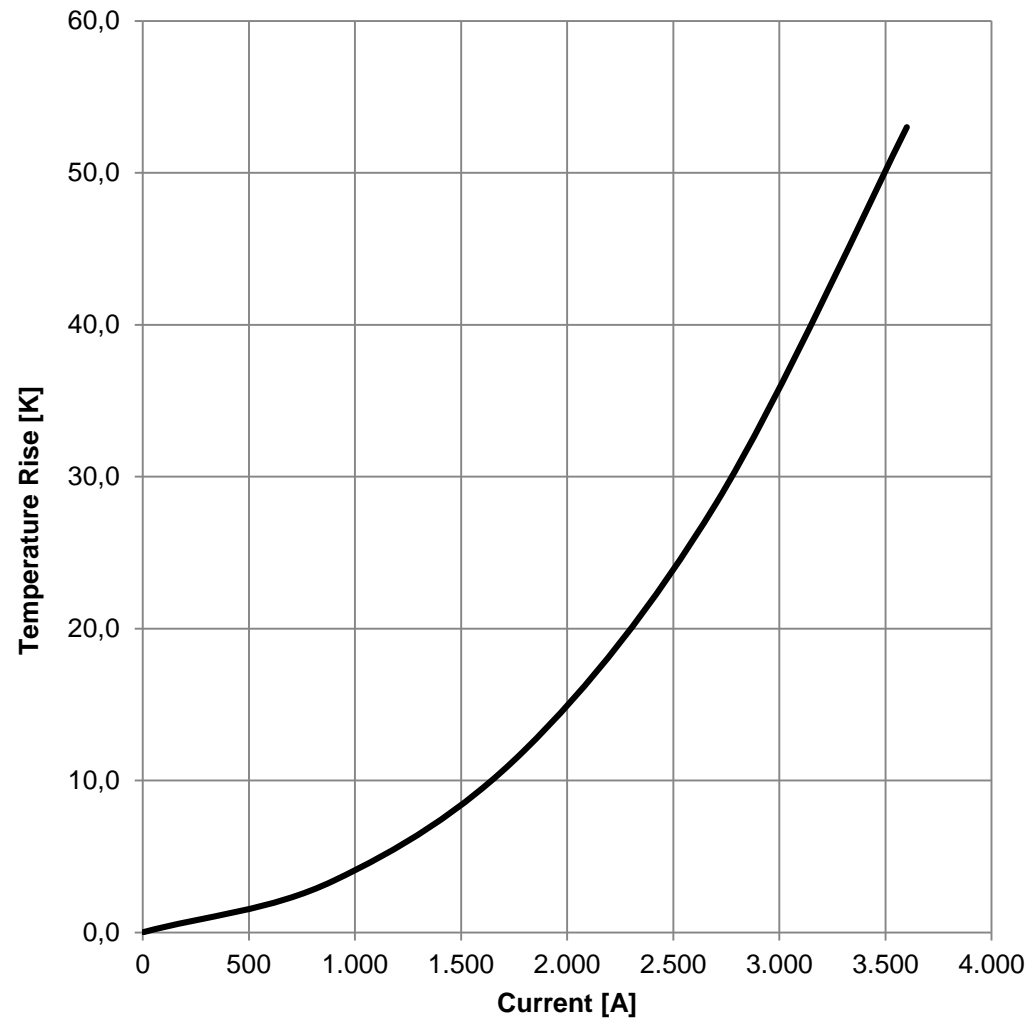
### Typical Inductance vs. Current Characteristics:

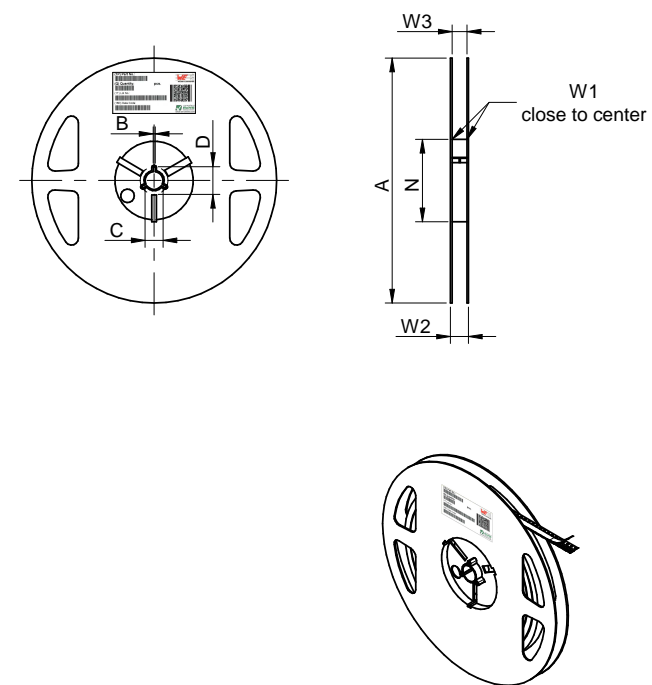
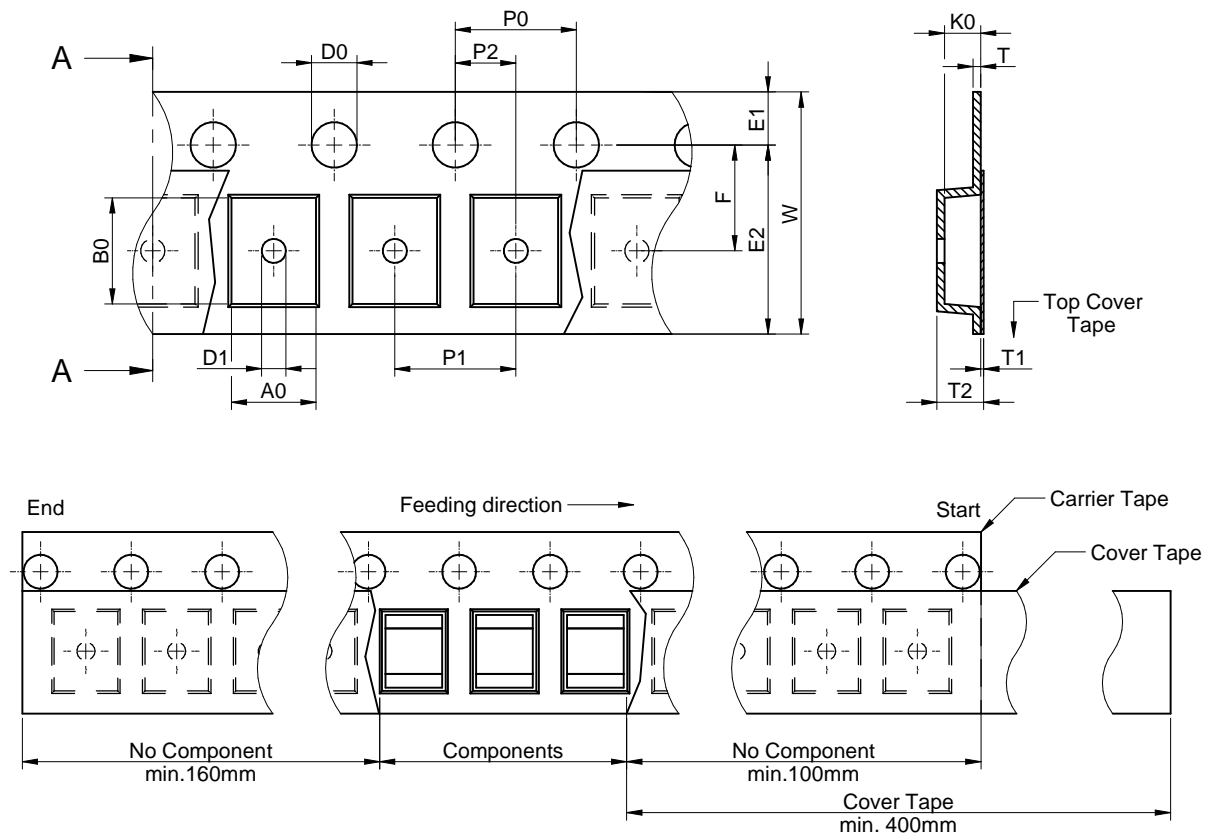
**Typical Temperature Rise vs. Current Characteristics:**

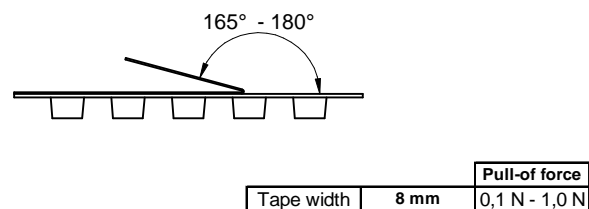




