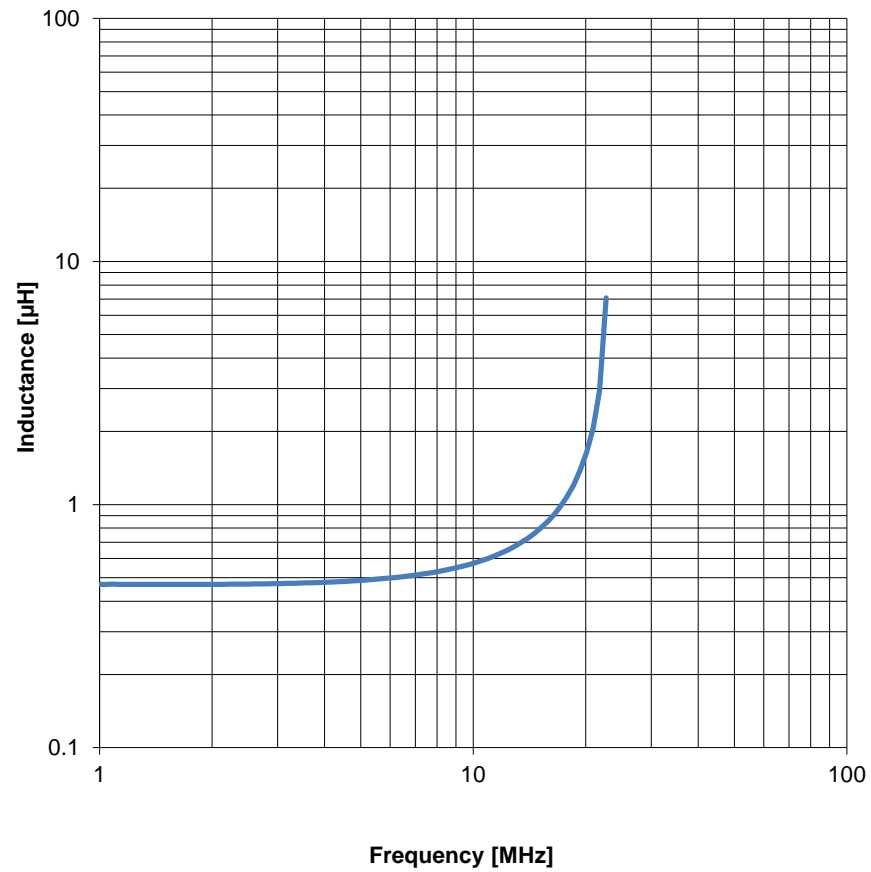

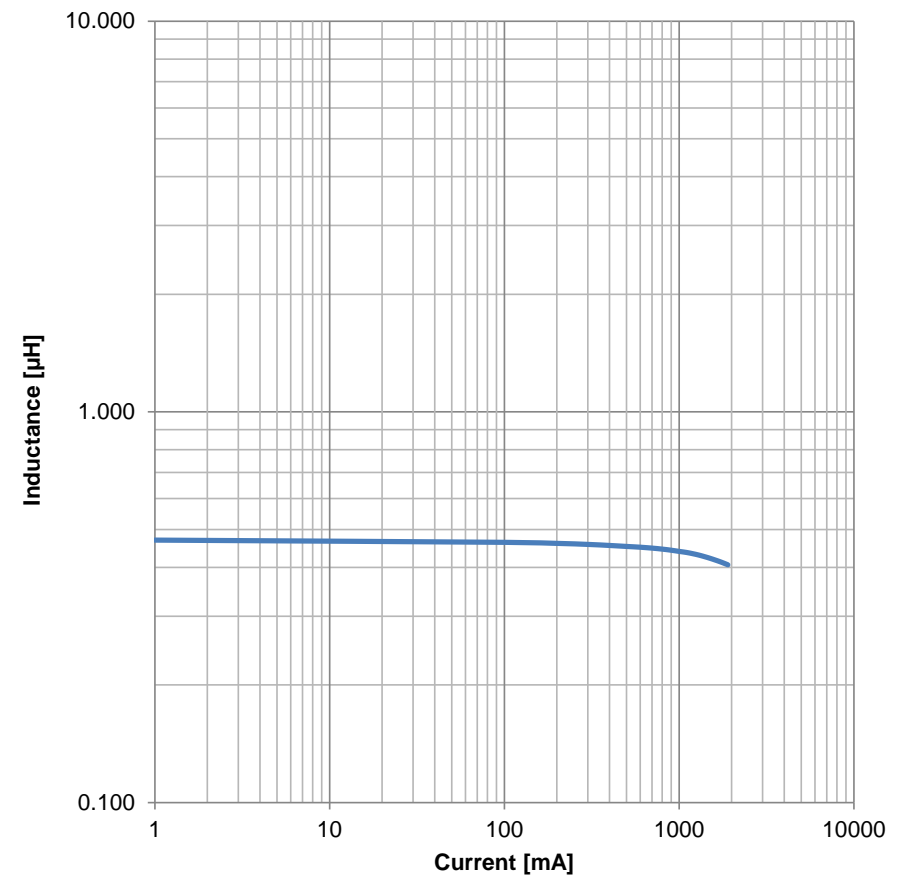

**Typical Inductance vs. Frequency Characteristics:**



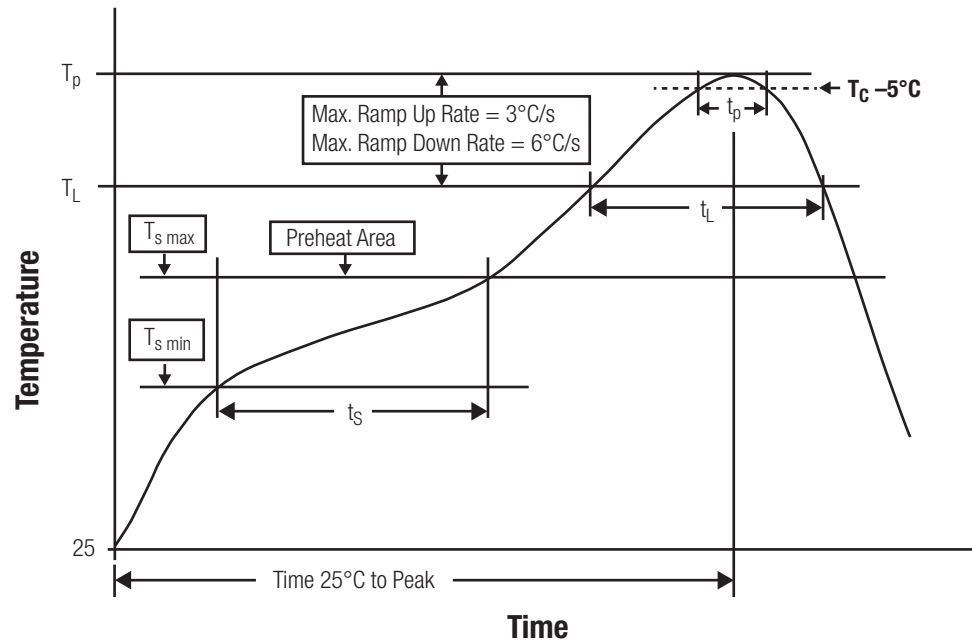
**Typical Inductance vs. Current Characteristics:**






