### Typical Attenuation:



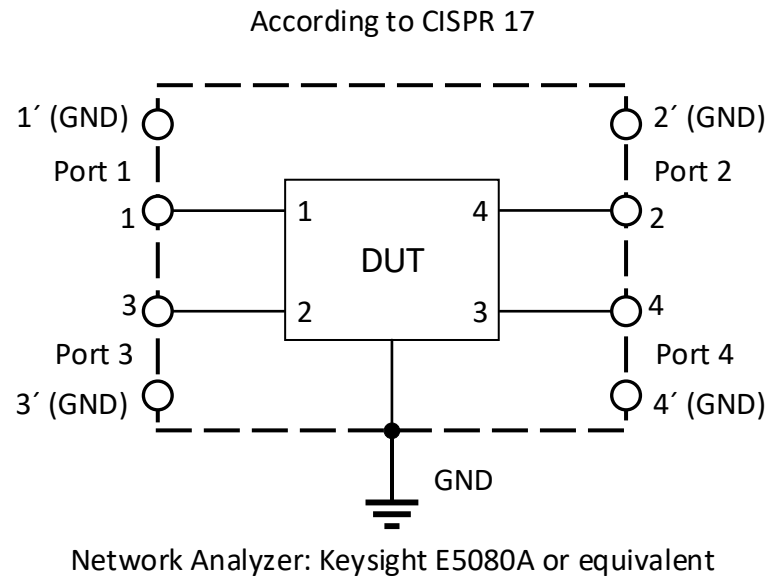
### Typical Impedance Characteristics:



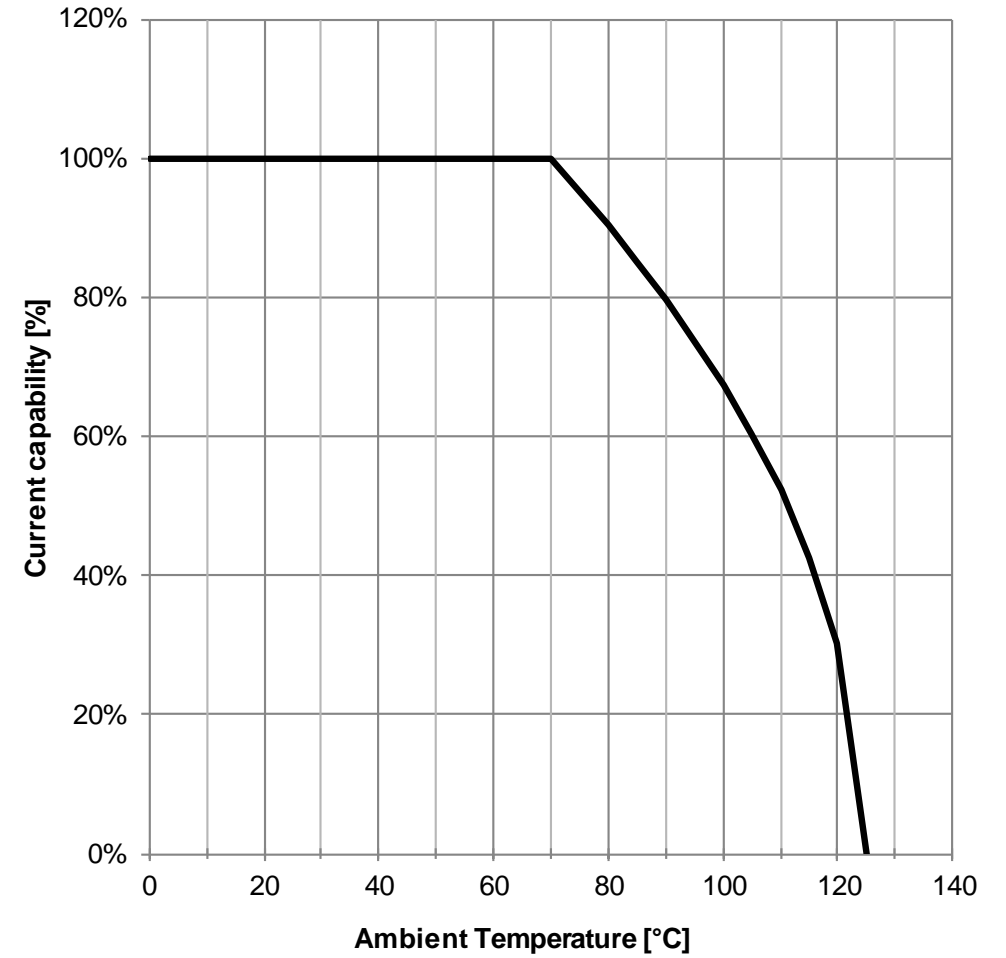

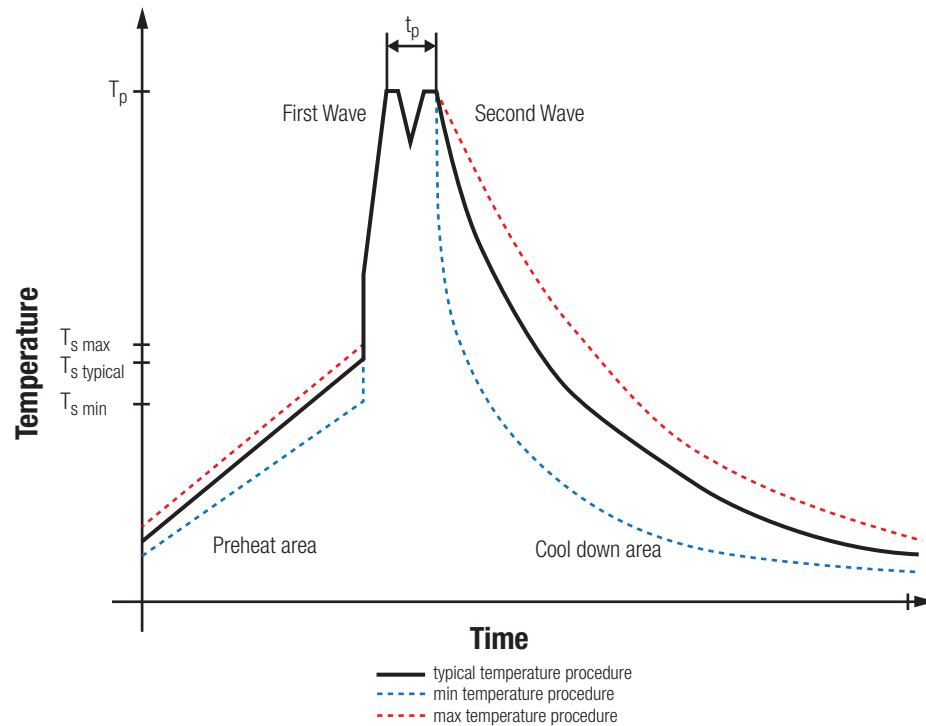
**Derating Curve:**






