### Typical Attenuation:

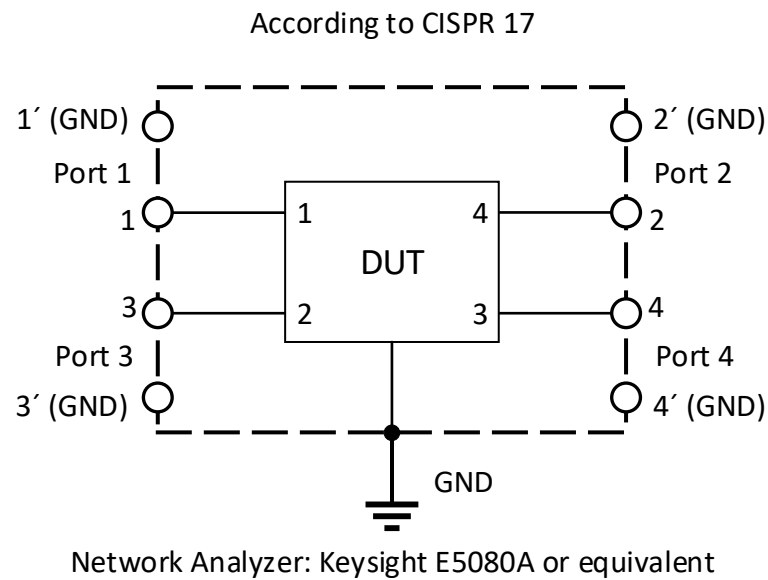


### Typical Impedance Characteristics:

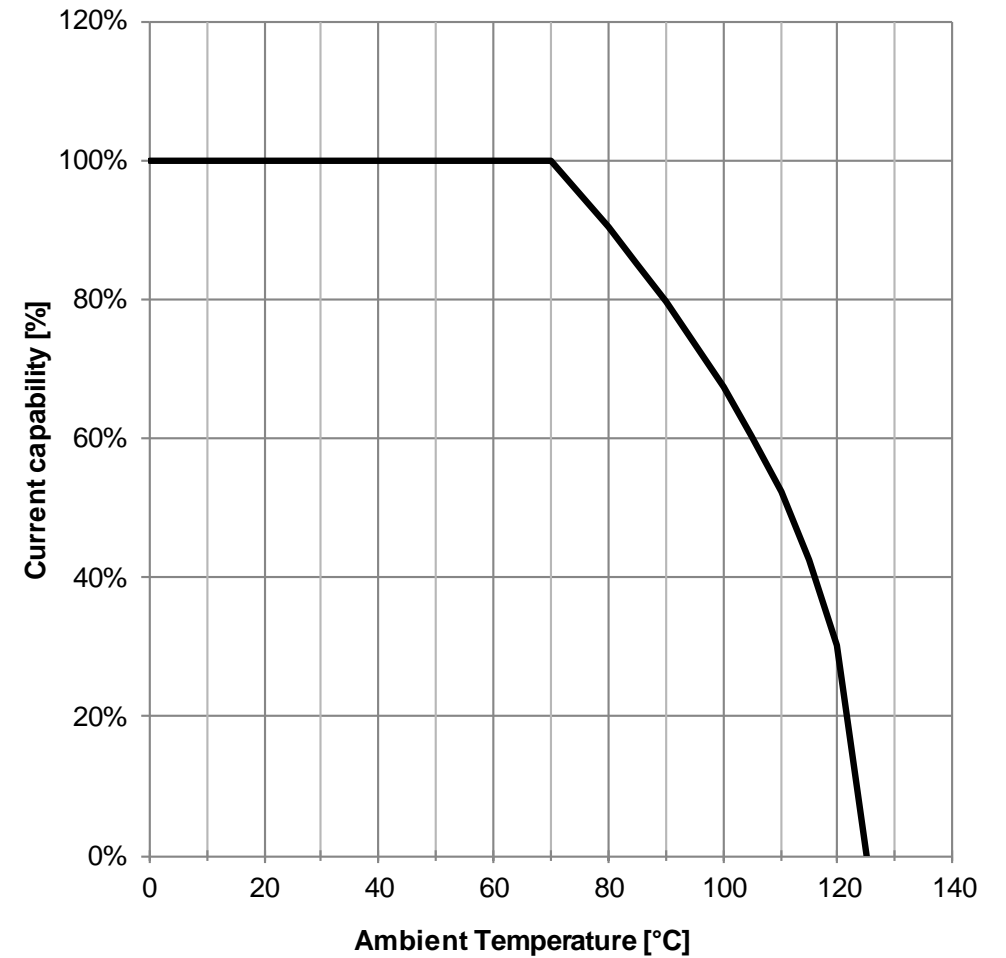
