Typical Attenuation:



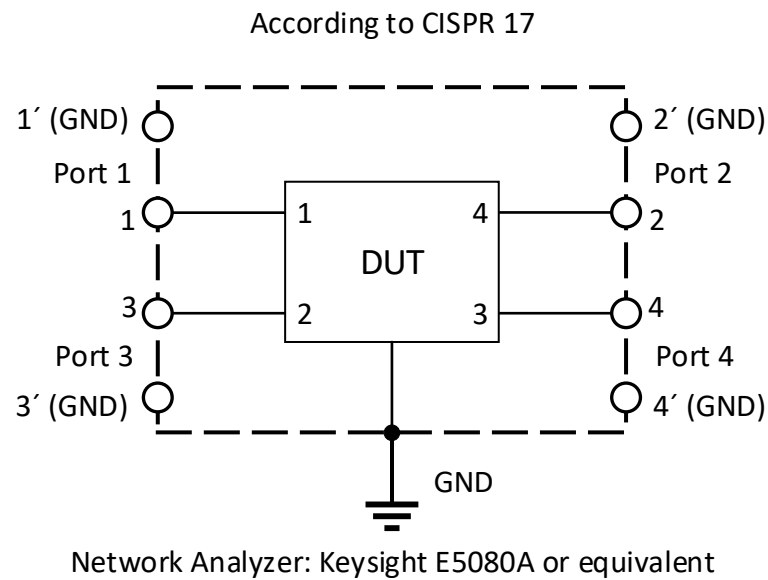
