### Typical Attenuation:



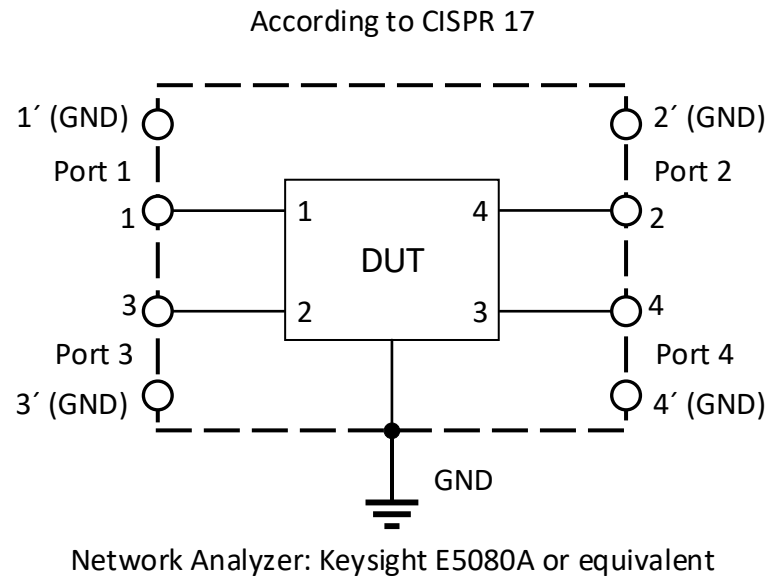
