Typical Attenuation:



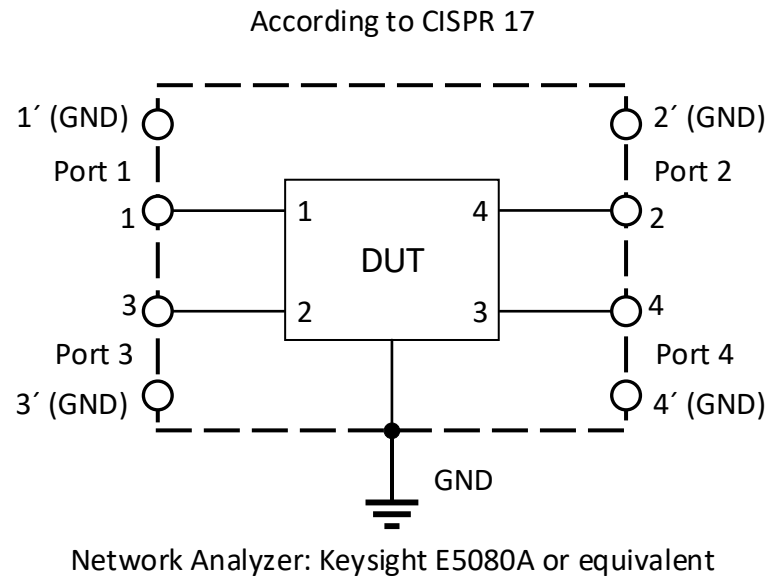
