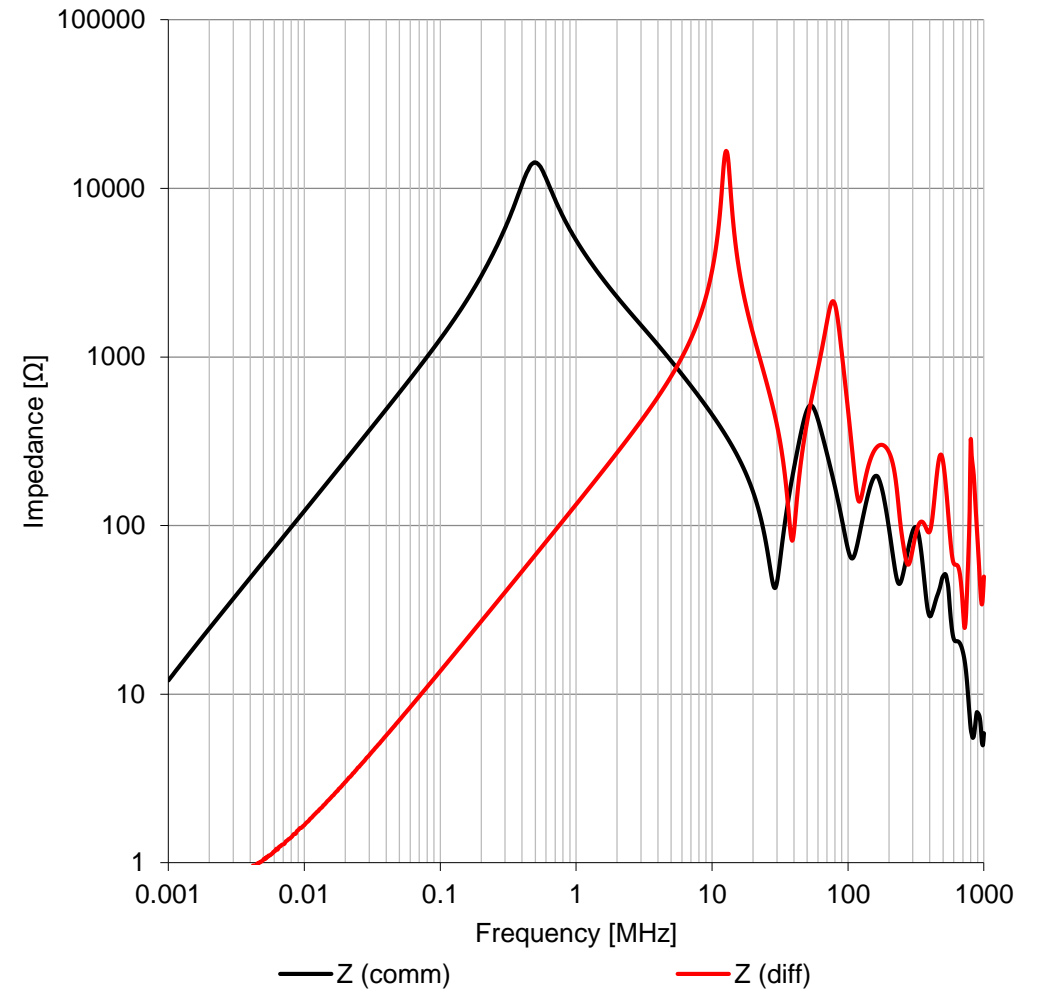

Typical Insertion Loss:



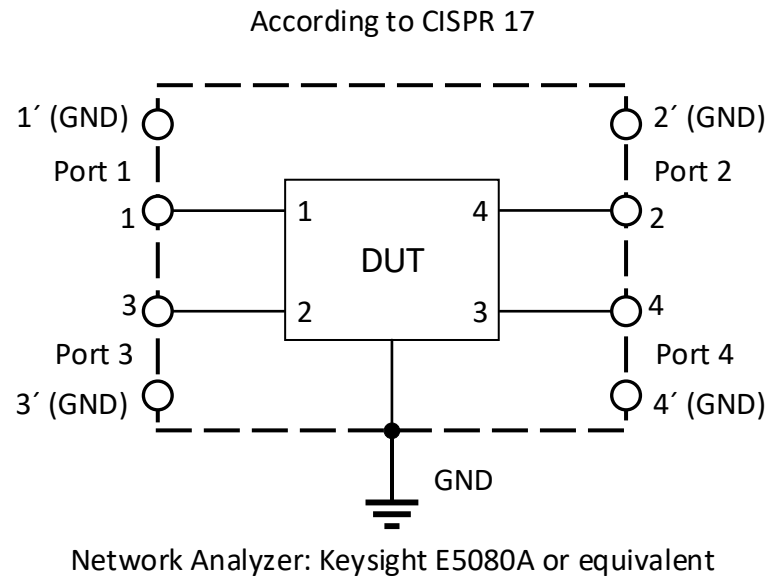
Typical Impedance vs. Frequency:



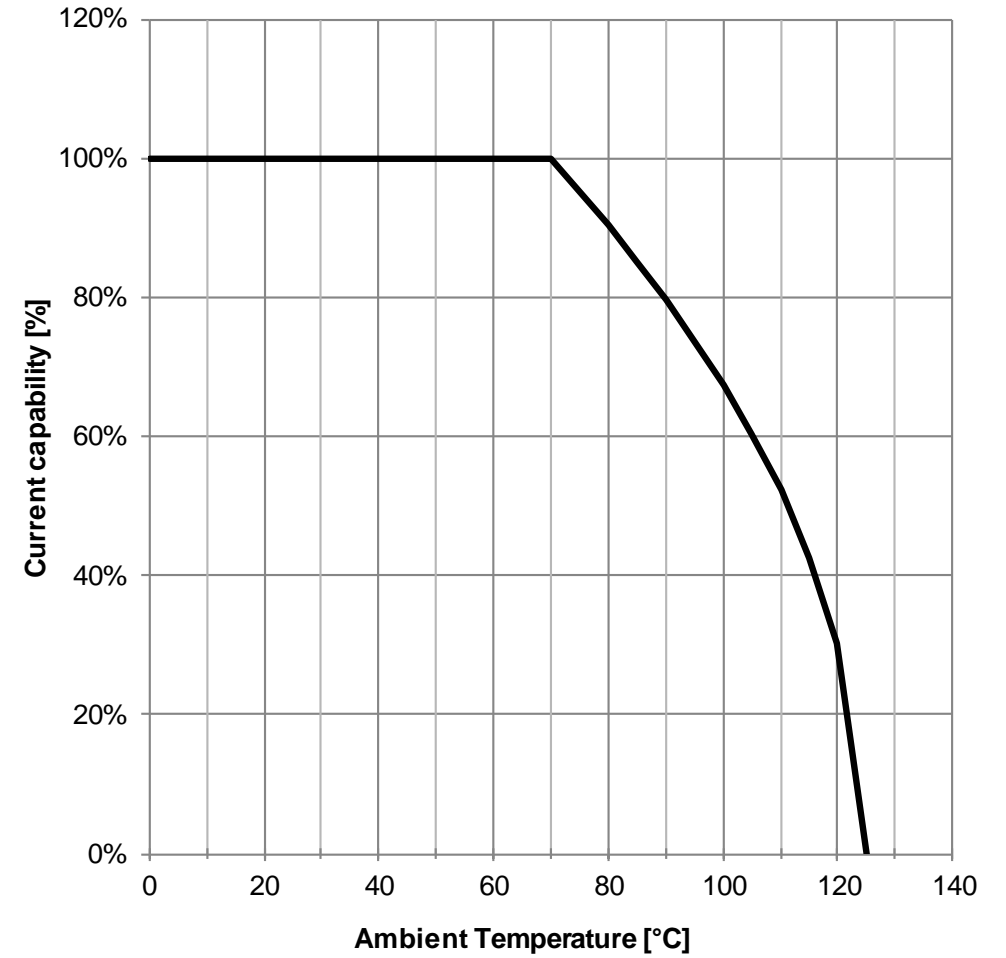
