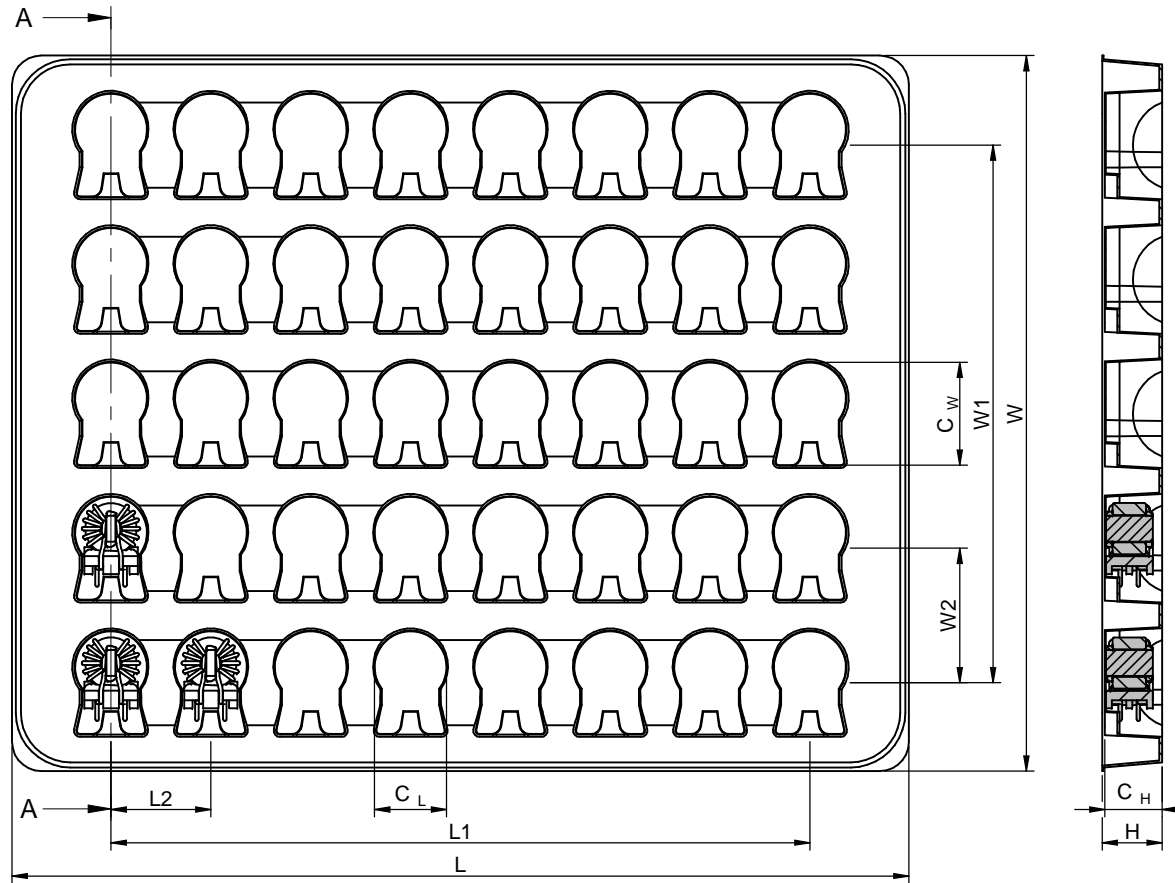
**Derating Curve:**



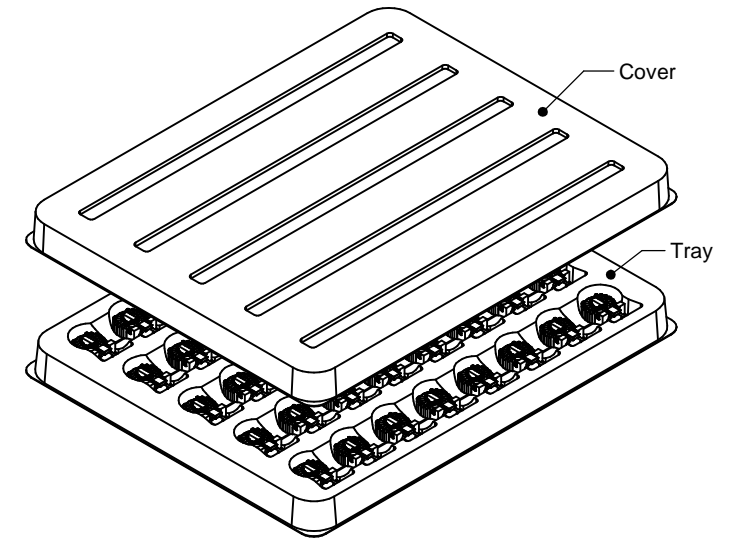
