### Typical Insertion Loss:



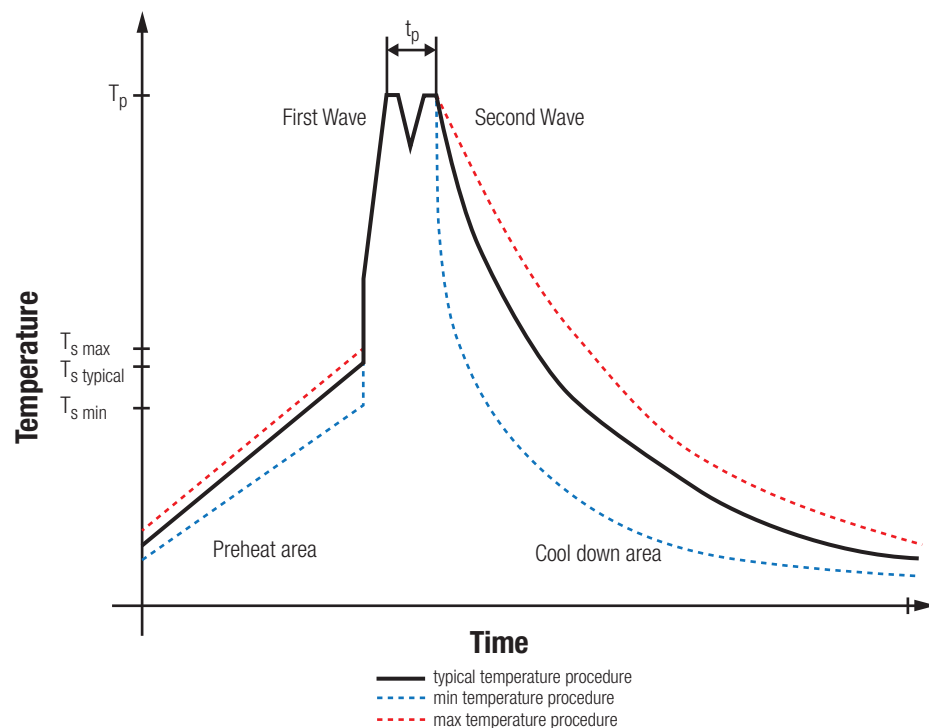




## Storage Conditions:


