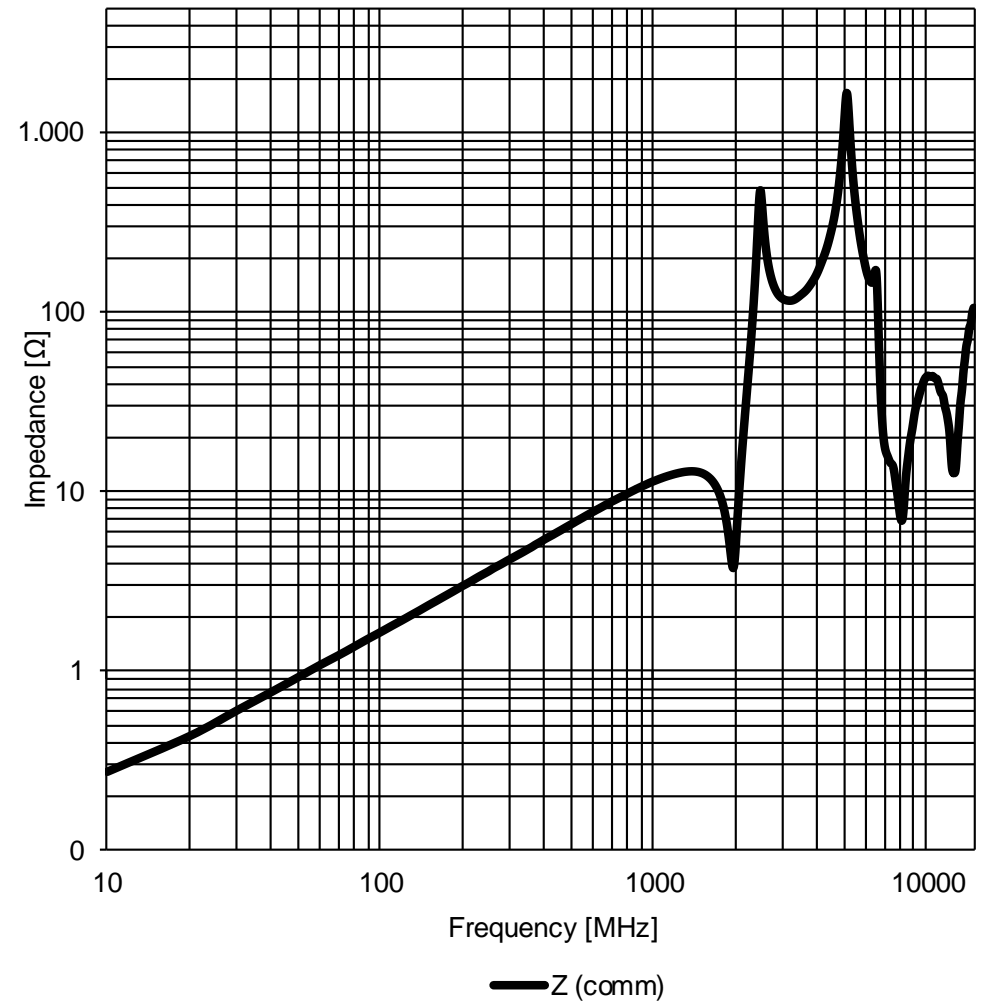

Typical Impedance Characteristics:



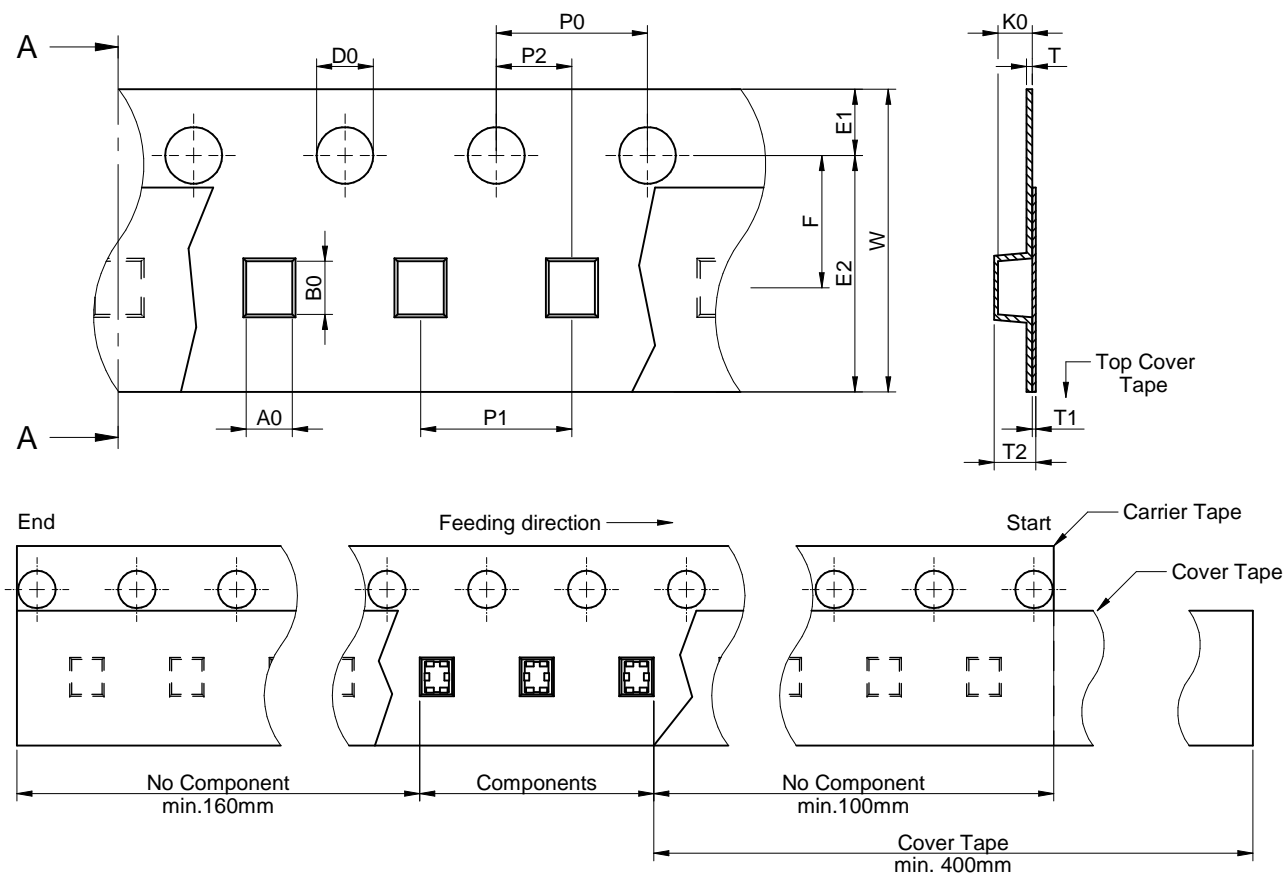
