### Typical Inductance vs. Current Characteristics:



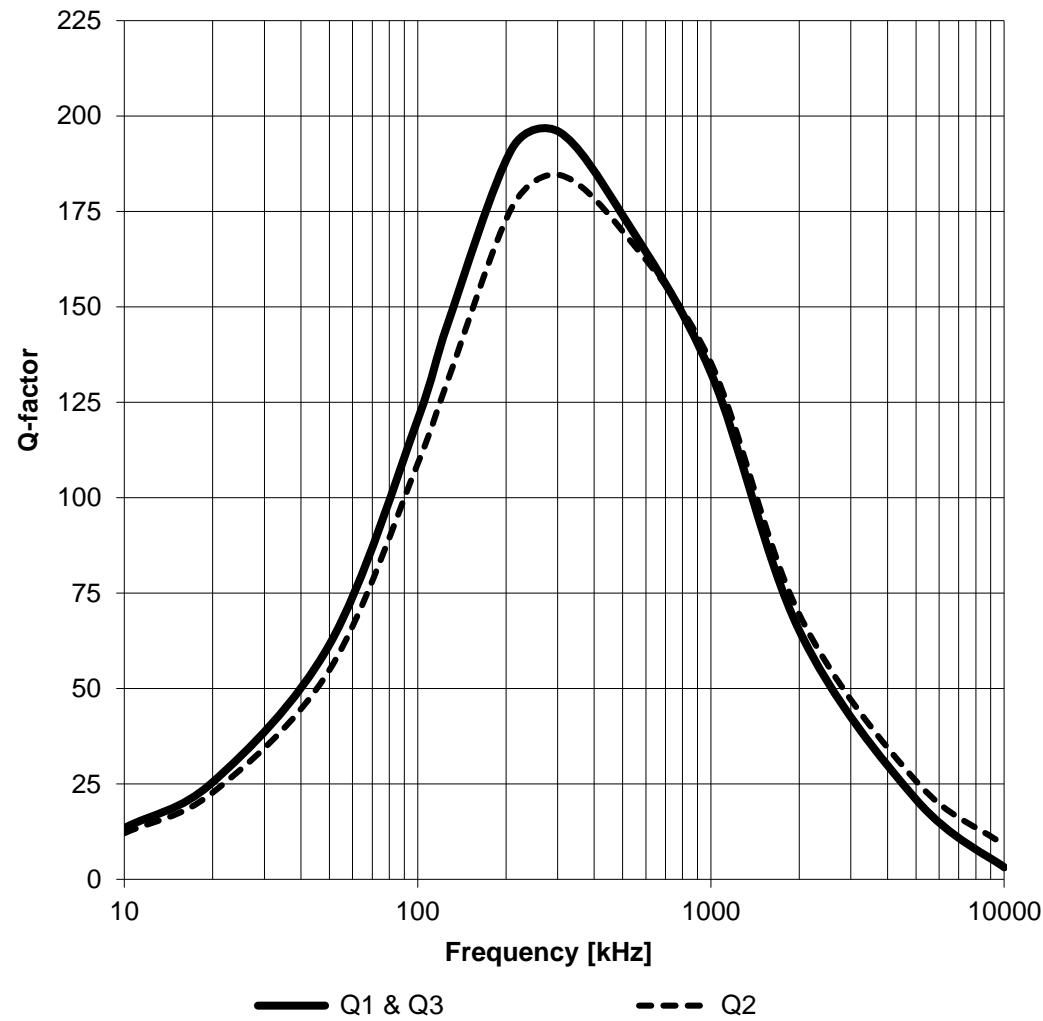
### Typical Inductance vs. Frequency Characteristics:



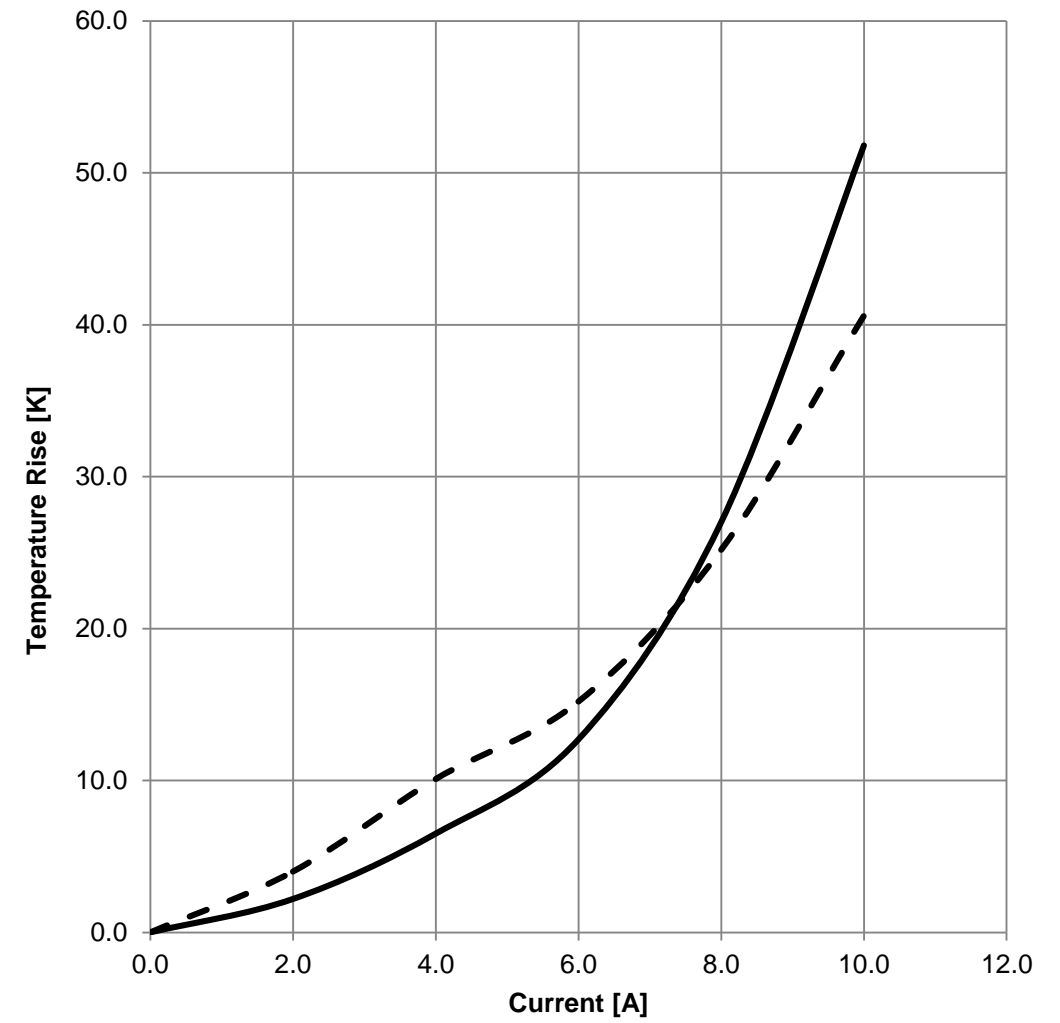



### Q-Factor vs. Frequency:



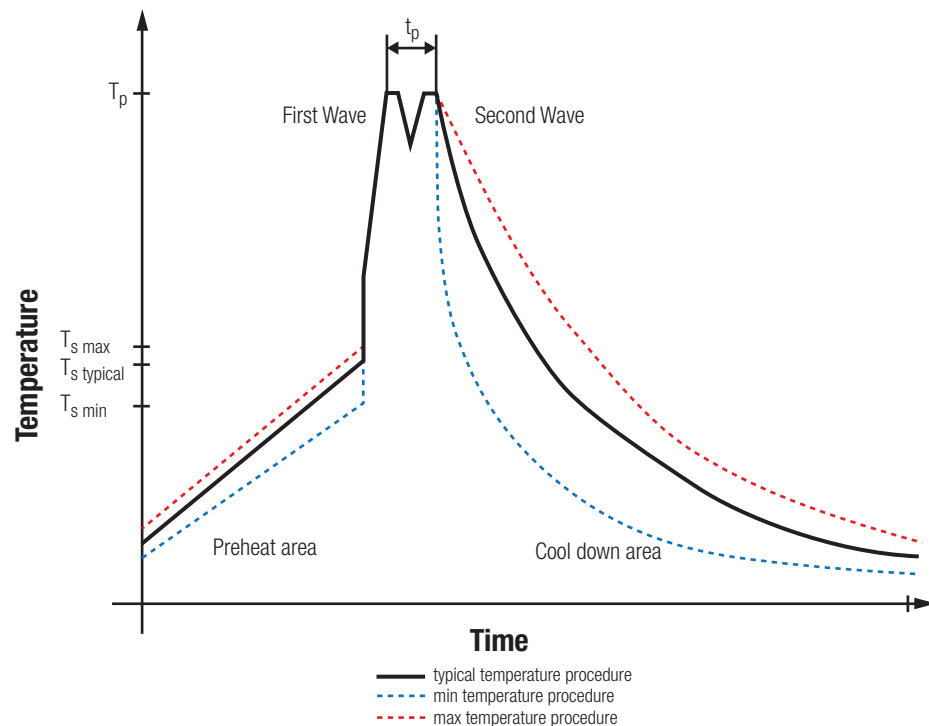
### Typical Temperature Rise vs. Current Characteristics:




Direct mechanical impact to the product shall be prevented as the ferrite material of the core could flake or in the worst case it could break.


