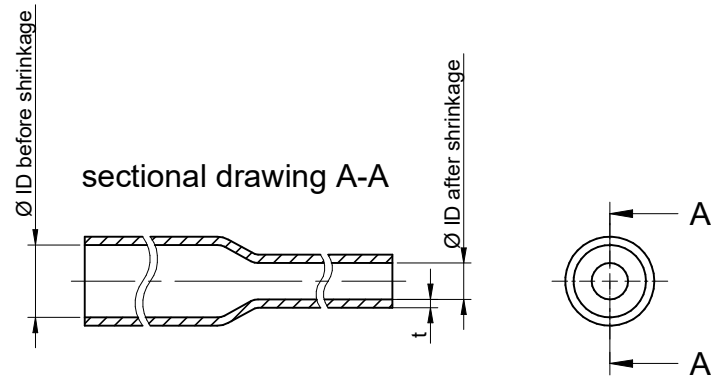

#### Product Specific:

#### Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the components. Washing agents may have a negative effect on the long-term functionality of the product.
- Using a brush during the cleaning process may damage the component. Therefore, we do not recommend using a brush during the PCB cleaning process.

#### Potting and Coating:

- If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinking could lead to an incomplete seal, allowing contaminants into the components. Expansion could damage the components. We recommend a manual inspection after potting or coating to avoid these effects.

#### Storage Conditions:

- A storage of Würth Elektronik products for longer than 12 months is not recommended. Within other effects, the terminals may suffer degradation, resulting in bad processability. Therefore, all products shall be used within the period of 12 months based on the day of shipment.
- Do not expose the components to direct sunlight.
- The storage conditions in the original packaging are defined according to DIN EN 61760-2.
- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.




#### Packaging:

- The packaging specifications apply only to purchase orders comprising whole packaging units. If the ordered quantity exceeds or is lower than the specified packaging unit, packaging in accordance with the packaging specifications cannot be ensured.

#### Handling:

- Violation of the technical product specifications will void the warranty.
- The shrinking process should start in the middle of the tube and continue to the outside. In this way, air inclusions are prevented. The shrink temperature specifications are minimum specifications, as not all parts/electrical components can be exposed to the same heat load. During shrinking, a higher temperature can be selected for a short time. The processing with the high temperature must only be done for a short time and with sufficient distance to avoid damaging. The heating time must be sufficient to allow the heat to escape during shrinking.
- The temperature rise of the component must be taken into consideration. The operating temperature is comprised of ambient temperature and temperature rise of the component. The operating temperature of the component shall not exceed the maximum temperature specified.


