

Product Specific:

Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the components. Washing agents may have a negative effect on the long-term functionality of the product.

Potting and Coating:

Storage Conditions:


Packaging:

Handling:

- The shrinking process should start in the middle of the tube and continue to the outside. In this way, air inclusions are prevented. The
 shrink temperature specifications are minimum specifications, as not all parts/electrical components can be exposed to the same heat
 load. During shrinking, a higher temperature can be selected for a short time. The processing with the high temperature must only be
 done for a short time and with sufficient distance to avoid damaging. The heating time must be sufficient to allow the heat to escape
 during shrinking.
- The temperature rise of the component must be taken into consideration. The operating temperature is comprised of ambient temperature and temperature rise of the component. The operating temperature of the component shall not exceed the maximum temperature specified.


